Subject:- Dealing grant of Building Permissions to the SRS projects in MCGM & Thane Municipal Corporation limit in the wake of containment/stoppage of Corona (COVID 19).

Reference:- 1. Circular issued by SRA Administration under No. SRA/12990/2020 dated 27th April 2020.
2. Orders of honourable Chief Secretary, Govt of Maharashtra issued on 02.05.2020 under No. DMU/2020/CR.92/DisM-1 & further orders issued under even number on 03.05.2020.

Sir,

You are aware that Government is putting constant efforts for containment of CORONA (COVID 19) including imposing Lockdown and simultaneously endeavouring to consider the fate of ongoing construction in the wake of lockdown imposed. In the process, Hon'ble Chief Secretary, Government of Maharashtra has issued orders on 02.05.2020 under No. DMU/2020/CR.92/DisM-1 & further orders issued under even number on 03.05.2020, scanned copies are enclosed.

2. You are further aware that SRA administration has also issued a circular on 27th April 2020 for issuing certain permissions to the urgent pre-monsoon works

to continue incomplete foundation/waterproofing works during the Lockdown period and such works are in progress.

3. Licensed professional (Licensed Architects, Licensed Surveyors, Licensed Structural Engineers, Licensed Site Supervisor & Licensed Plumbers) are required to travel within MCGM/TMC limits for supervision of such works and they shall require a “Travel Pass” to commute to various sites.

4. SRA administration has decided to issue “Travel Passes” to all such practising firms may be limiting the maximum to 10 numbers for commuting within MCGM/ TMC limits only till the expiry of Lockdown.

5. The “Travel Passes” to the Developers shall be for commuting to the respective sites with a validity till expiry of “LOCKDOWN PERIOD” & whereas the validity of ‘Travel Passes’ issued for shifting of labourers from one site to another site shall be for maximum 2 days, for commuting within MCGM/TMC limits only. The “Travel Passes” to the Developers shall be issued by respective EEs in whose jurisdiction particular site falls, their domain email IDs are already shared.

The “Travel Passes” to the Licensed Professionals shall be valid till expiry of Lockdown period for commuting anywhere in MCGM/ TMC limits depending on the requirements at various sites. The “Travel Passes” to the Licensed Professionals shall be issued by AE Shri. Rajesh Yadav by email through his domain email Id (ae5@sra.gov.in), in order to avoid misuse.

5. Kindly convey to your members and other licensed professionals accordingly, as well as, circulate this letter amongst your members electronically.

6. You are also requested to inform your members to use the “Travel Passes” judiciously only for bonafide intended purpose only, as well as, advice the Developers to use the “Travel Passes” judiciously to avoid misuse & in turn avoid untoward legal action mentioned in the orders of Hon’ble Chief Secretary, Govt of Maharashtra, referred as above.
