Sub.: Advisory to SEAC Committees to start hearing cases with built up area 20000 to 50000 sq.mtrs.

Ref.: 1. MoEF Notifications dated 14.11.2018 and 15.11.2018

2. Delhi High Court stay order dated 26.11.2018

3. NGT stay order dated 03.12.2018 (copy attached for ready reference)

Respected Sir,

It may be brought to your kind notice that vide its Notifications dated 14.11.2018 and 15.11.2018 issued by the MoEF, whereby the MoEF had delegated all its powers to the local authorities including municipalities, district panchayats etc. in respect to building or construction projects with built up area 20000 to 50000 sq.mtrs. and for a built up area of 20,000-1,50,000 for industrial sheds, hospitals, educational institutions.

Subsequently, NGT vide its order dated 03.12.2018 and a Division Bench of the Delhi High Court vide their order dated 26.11.2018 stayed the said MoEF notification, and directed that "the existing mechanism prior to the said notification will continue till further orders".

Post the stay order, hearing of all MoEF cases between 20000 to 50000 sq.mtrs. by the SEAC Committees have stopped on the grounds that they don't have any direction from MoEF as of now. The projects that fall in the range of 20000 to 50000 sq.mtrs. are suffering and the respective project proponents may face heavy penalties as an outcome of this in the future, under the provisions of MahaRERA.

- 1. Sir, it is CREDAI-MCHI's collective plea that now that the Hon'ble High Court & NGT have stayed the MoEF Notification delegating their powers to the local authorities, the SEAC Committees should be instructed to start hearing all the cases between 20,000 to 50,000 sq.mtrs. & provide relief. SEAC being an appraisal committee, could, irrespective of the court orders, continue the appraisal as appraisals do not guarantee or accord approval to a project.
- 2. It is also our sincere plea that in case of projects like having rehabilitation of slums like SRA, or projects which could be eligible for PMAY, or projects which fall under Affordable Housing Category like flats of 30 sq.mtrs. / 60 sq. mtrs. that could be considered as public





purpose projects, as also projects that involve building and handing over land and developing a school, fire brigade etc., such proposals, which are in the nature of accommodation reservation development or which involves development of a reservation or any other sort of PPP, should be given a priority in the hearing.

3. Sir, it may kindly be noted that on the occasion of CREDAI National Investiture Ceremony 2017, held on 9th April, 2017 at Gandhinagar, to provide reality to our Hon'ble PM's vision of "Housing For All", 250 Affordable Housing Projects were unveiled by Shri Venkaiah Naidu, then Hon'ble Minister HUPA (copy of invite of ceremony attached for your ready reference). Every project proponent of these 250 projects had individually entered into an MoU, a sample copy of one such MoU is attached herewith for your ready perusal and records. Our Hon'ble PM had acknowledged this great initiative vide his congratulatory note, copy attached.

CREDAI-MCHI, on its part, had separately entered into an MoU during the Magnetic Maharashtra: Convergence 2018 held at Mumbai from 18th to 20th February 2018 to facilitate development of **2.54 Lakh Affordable Houses** under Pradhan Mantri Awas Yojana (Urban) in Mumbai Metropolitan Region (MMR) through its members in a time bound manner. As part of the MoU, the following was committed:

"The Government of Maharashtra will facilitate the members of CREDAI-MCHI, to obtain necessary NOCs / permissions / registrations / approvals /clearances/ incentives etc. on priority from the concerned departments of the State, as per the existing policies / rules and regulations of the Government of Maharashtra."

Sir, we only pray that all these projects, 250 under MoU with HUPA and those under which 2.5 lakh homes were offered under MoU with Govt. of Maharashtra, be given priority as and when the project proponent applies for it.

We earnestly look forward to your advice as the projects have come to a standstill.

ORDER

- 1. Grievance in this application is against notification dated 14.11.2018, issued by the Ministry of Environment, Forest and Climate Change (MoEF&CC) under Section 23 of the Environment (Protection) Act, 1986, delegating power for grant of Environmental Clearance (EC) for construction projects with built up area more than 20,000 sq. meters to 50, 000 sq. meters and industrial sheds, educational institutions, hospitals and hostels for educational institutions more than 20,000 sq. meters utpo 1,50,000 sq. meters, along with building permission, to Local bodies such as Municipalities, Development Authorities, District Panchayats. Prior to the said notification, Environment Impact Assessment was being done by a credible mechanism by MoEF&CC itself. The same was sought to be delegated earlier which was disapproved by this Tribunal. Present notification is, thus, in the face of earlier NGT order approving such exercise.
- 2. Learned counsel for the applicant submits that delegation of powers in the impugned notification renders EIA Notification dated

14.09.2006 having safeguards for protection of environment to be futile.

It is submitted that conducting or non-conducting EIA by a credible mechanism is not a matter of discretion but a power coupled with duty to uphold the concept of sustainable development as well as 'Precautionary Principle'. The said concepts are a part of Article 21 of the Constitution and are required to be upheld by this Tribunal under Section 20 of the National Green Tribunal Act, 2010.

- This Tribunal dealt with the issue vide judgment dated 3. 08.12.2017 in Society for Protection of Environment and Biodiversity Vs. Union of India & Ors. - 2018 NGTR (1) B 1, and struck down the dilution of norms for Environment Impact Assessment which were found to be deviating from the 'Precautionary Principle' by delegating such power to the local authorities which was held to be a retrograde step. It is failure of the local bodies to apply law which has led to large scale violation of town and country planning laws and the resultant environmental degredation. If such constructions are exempted from the purview of the Expert Appraisal Committee, it will amount to failure to protect the environment, which is the duty of the MoEF&CC under the Environment (Protection) Act, 1986, which was enacted to give effect to the international commitment under RIO Convention, 1992. Reliance was placed by the Tribunal in the judgment of the Hon'ble Supreme Court in the case of N.D. Jayal v. Union of India, (2004) 9 SCC 362, laying down that adherence to Sustainable Development Principle is mandate of Article 21 of the Constitution. De-centralisation of mechanism regulation may be desirable but the same has to be by a credible mechanism.
- 4. In view of settled law on the point, we are *prima facie* of the view that mechanism in the impugned notification to substitute the existing mechanism will fall short of the requirement of the principle

of 'Sustainable Development' and 'Precautionary Principle' which are part of Article 21 of the Constitution as laid down by the Hon'ble Supreme Court in in the case of N.D. Jayal v. Union of India (supra).

Accordingly, while issuing notice, we stay operation of the impugned notification and direct that existing mechanism, prior to this notification will continue till jurisher orders.
