Reference is please requested to the representation From M/s. SanjeevaniVyapar LLP as at pg C-1 requesting this office to intimate AE (B & F) S ward to revoke the stop work notice issued for want of NOC from Navy authorities. Further various proposals are submitted to this office through online system thereby requesting to process the proposals for grant of OCC, CC/ IOD without insistence of NOC from Navy.

The list of the various applications/ proposals already submitted for NOC from Naval authority is enclosed herewith at pg C- 125 to C-129.

Ref. is further requested to the reports submitted on representation of M/s. Kanakia Spaces Reality Pvt Ltd to Ch. E. (DP)/ Dir. (E. S. & P.) at Pg. No.C-95to C-115 & order of Hon'ble M.C. thereon dtd. 23.01.2020 as at pg C- 112 and dtd30.01.2020 at Pg.No. C-115 please.

The gist of the matter is reproduced as under:

- 1) As per the circular issued by Chief Secretary (UD-1) u/no. CRZ-2012/C.N. 2/12/UD-12 dtd 21.02.2015 & Joint Secretary u/no. CRZ-1215/1093/CN 40/15/UD-12 dtd 20.04.2016, NOC from the Local defence Authority is being sought for allowing any development within 500 Mtrs any Defence establishment wherein development permissions are issued after **18.05.2011**.
- 2) Modified guidelines are issued by Dy.Dir.(Lands) of MoD on **21.10.2016**. However, these guidelines are not applicable to Naval Establishment.
- 3) In W.P. no. 3013 of 2018, order was passed by Hon'ble High-Court on **27.02.2019** wherein Hon'ble High-court has given relief for the development of proposal submitted by ShubhNiketan CHS vide no. CHE/ES/1663/S/337(NEW); which was falling within 500 Mtrs. From Naval Civilian Colony at Kanjurmarg (w).
- 4) Hon'ble High-Court has passed another order on **27.09.2019** in N.M.(L) no. 476/2019 in W.P. 3013/2018 that the judgement dtd. 27.02.2019 in W.P. no.3013 of 2018 is binding on similarly placed projects in the same vicinity.
- 5) Meanwhile, the above cited order dt. 27.02.2019 of Hon'ble High-Court was challenged by Navy Union of India in Hon'ble Supreme Court vide SLP (civil) diary no 36126 of 2019 and the same was dismissed on the ground of delay on **25.10.2019**.
- 6) A letter is received in this office addressed by Shri. KuldeepDadwal, Commander, - Senior staff officer (Land & Construction) for Flag Officer-Commanding- in- Chief to The Principal Secretary, Urban Development Dept, GoM vide no. WK/3031/NOC/28/104 dtd. **30.10.2019** as pg C-581 recommending thereat
"GoM, UDD Circular dated 07 November 2016 and subsequent clarification issued on the subject to MCGM in August 2019 be amended & fresh instructions may be issued to all the planning authorities in Maharashtra to follow GoI, MoD guidelines dated 18 may 2011, 18 march 2015 and 17 November 2015 in respect of Indian Navy Units/Establishment".
The Copy of said letter is forwarded to the Municipal Commissioner, MCGM with a request to continue forwarding building proposals for NOC to HQWNC as hitherto.
- 7) Further, the matter was referred to Hon'ble A.G. & accordingly Hon'ble A.G. has opined on **18.12.2019** that the judgement dtd. 27.02.2019 and order dtd. 27.09.2019 passed by Hon'ble High-Court in W.P. no. 3013 of 2018 is applicable to all project in the vicinity of Naval Civilian Colony.

8) After perusing all the facts, a detailed report was submitted to Hon'ble M.C. sir in one of the case situated in KanjurMarg area stating that "in view of the order of Hon'ble High Court dtd.27.02.2019 and in view of the opinion of Adv. General, it is felt that all proposals situated in the vicinity of Naval Civilian Housing Colony, Kanjurmarg, Mumbai, may be processed treating the identical & similarly placed project and NOC from the Navy will not be insisted."

Hon'ble M.C. sir vide MCP/671 dtd. **31/01/2020**(copy at pg. C-155)approved the same. Hon'ble M.C. sir has accepted the proposal that all the development projects situated in the vicinity of Naval Civilian Hsg. Colony will be processed treating as identical & similarly placed projects at Kanjurmarg.

9) However, it is observed that, Navy is still fixed on their views as per recent remarks as below.

i) Lieutenant Commander, Staff Officer, (Lands), Head Office, Western Naval Command, Mumbai vide letter dtd**11-11-2019** under no WK/3031/NOC/40/NM/12 (copy at pg. C-121)had issued clarification on order of Hon'ble High Court dtd 27-09-2019, in Notice of Motion (NOM) No 476 of 2019 filed by NarrotamChittranjan Sharma. The same is attached herewith. Para 2 and 4 are reproduced here:

Para 2: Hon'ble Bombay High Court has vide para6 of ibid order upheld the process of grant of NOC and stated that "....the court has not granted any relaxation from conditions imposed by the planning authority in terms of its regulation and it goes without saying that the judgement is binding on all similarly placed projects in the same vicinity."

Para 4. In view of the above, it is requested that all proposals, pertaining to the construction within the vicinity of NCHC (Powai), be forwarded to IN as hitherto keeping in mind the extant MoD guidelines on the subject."

ii) Vide latest communication u/no. WK/3031/NOC/96 dtd**06.02.2020**(copy at pg. C- 123)in one of the similar proposal for proposed residential building on plot bearing C.T.S. 
In this case the Rear Admiral Chief Staff Officer (P&A) for Flag Officer Commanding-in-Chief vide letter u/no. WK/3031/NOC/96 dtd 06.02.2020 has stated vide point no 3 that N.O.C. cannot be issued for above construction in accordance with extant guidelines issued by GoI, MoD.

In view of the recent communications by Naval authority, approval of Ch.E. (D.P.) & Dir. (ES & P) / Hon'ble M.C.'s approval is requested:

1) To set aside the refusal / rejection letters communicated by Indian Navy wrt correspondence made in several cases prior to the order of Hon'ble High court for development projects in the vicinity of Naval Civilian Housing Colony, Kanjurmarg(W).

2) To revoke the Stop work orders issued to the similar proposals i.e. in the vicinity of Naval Civilian Housing Colony, Kanjurmarg, for want of NOC from Indian Navy & issue further approvals wrt provisions under DCR - 1991 / DCPR - 2034, as applicable.

Reference is further requested to the endorsement of Ch.E.(D.P.) & Dir(E.S.&P.) dated 11.03.2020 at pg. N-6 which has been duly endorsed by Hon. M.C. The endorsement of Ch.E.(D.P.) & Dir(E.S.&P.) is reproduced as under:

It is to submit that being the urgent & critical matter, Shri JayeshDusane, A.E.(B.P.)S&T personally went to the concerned Naval office on 22.04.2020 to deliver the letter u/no. DyChE/BP/11821/ES dated 21.04.2020. However, the concerned Naval Office had refused to accept the said letter stating the reason of pandemic situation as such the said letter could not delivered to Navy till today.

Reference is further requested to the document received from Legal Department through e-mail on 12.06.2020 that theNavy has once again preferred an appeal in Hon. Supreme Court by way of Special Leave Petition vide Diary No. 8474/ 2020 against order of Hon. High Court dated 27.09.2019 in NM (LD) 476/2019 in WP 3013/2018. (Union of India Vs NarottamChittranjan Sharma & Others) (C-133 to C-159).

As the decision of M.C.G.M. is based on opinion of Hon. A.G. dated 18.12.2019 which in turn is entirely based on above cited order of the Hon. High Court dated 27.09.2019 in NM (LD) 476/2019 in WP 3013/2018 (Union of India Vs NarottamChittranjan Sharma & Others) and as the said order of the Hon. High Court has been challenged in the Supreme Court, it is felt that

it will be prudent to await for the order of the Hon. Supreme Court in above mentioned SLP please.
