As you are aware, MCHI-CREDAI, as an association, has been engaged in the Pursuit of development of *Affordable Housing*. While Affordable Housing is lauded, extolled and spoken about much in meetings and fora, the goal remains elusive, and illusory. Because the prevailing ground realities in metropolitan cities like Mumbai and MMR make it next to impossible to work towards this goal.

The sky-high prices of land, (sometimes constituting 60% of the project cost) and a plethora of overlapping procedural rules and regulations that not only inhibits, but actually retard whatever progress is achieved in a project. A project, undertaken with a great deal of effort, after securing countless permissions, NOCs and what-have-you, is brought to a standstill, because of a sudden change in rules, imposed without much warning.

In this context and for your kind reference, I am enclosing a complete docket of correspondence, with letters addressed to the Hon'ble Minister for Environment in the Ministry of Environment & Forests, and other functionaries of the Maharashtra State and Central Governments, the letters deliberate the problems that developers face in Mumbai, vis-a-vis Environments, Clearances, the resultant delays span a period of 18 to 24 months seriously affecting all project estimates.
