Dear Sir,


Legal Metrology Organisation arranged series of meetings with department officials and with Hon'ble Shri Girish Bapat, Minister for Consumer Protection Department to discuss the draft rules which could be incorporated to Legal Metrology Act, 2009.

In spite of that, MCHI-CREDAI feels that we should follow the official line of action to adopt this procedure for incorporation of Rules in the said Act. Normally government provides some specific period of 30 days to 3 months to invite suggestions, with vide publicity to get the concerns & views from people or connected stakeholders related to the matter. But in our matter we are taking the steps very hurriedly which is not justifiable. Hence I would like to suggest that we could finalise a well thought of draft by everybody's views. Even Hon'ble minister felt that we may spent more time but could prepare a well thought of well studied final draft. So that, there is no problem in future for its implementation.

Therefore, I would like to request you that, please provide time of 30 days at least to make and submit final suggestions of draft Rules from MCHI-CREDAI
