Respected Sir,

This has reference to Meeting conveyed under the chairman ship of Chief Secretary Govt. Of Maharashtra on 18/7/2019 when Secretary (UD-1), Municipal Commissioner, CEO MHADA, representatives of MCHI /NAREDCO/PEATA/ Borivali Developers Associations were present. MCHI/NAREDCO/ PEATA submitted their representations to take necessary urgent steps to reduce Development Charges, Development Cess, Fungible compensatory area premiums, Additional FSI premiums, Open space deficiency premiums, Staircase lift lobby free of Area premium.

Vide letter of Hon'ble Municipal Commissioner to Hon'ble Principal Secretary - Urban Development in July 2019, MCGM had stated that 'As regards premium towards granting staircase/lift are free of FSI, the same will be dealt with at level of MCGM, after obtaining the sanction of Standing Committee / Corporation.'

On receipts of remarks from MCGM vide their letter dated 25/7/2019 & 2/08/201 & CEO MHADA vide letter dated 27/7/2019 Government of Maharashtra has issued directive u/s 154 of MRT act vide TPB-4319/189/CR/-123/2019/UD-11 dated 20th Aug 2019 in the public interest for reduction of premiums w.r.t Additional FSI premiums, Fungible FSI premiums, Development Cess.

However, the policy regarding reduction in premiums w.r.t. Staircase lift lobby free of FSI is not yet published by MCGM in the public interest as done by Government of Maharashtra in Aug 2019. This has led to discrepancy whereas staircase premium is extremely high (as high as 50% for commercial building for which fungible FSI premium itself is 40%) and is affecting the progress of projects since there the premium is unaffordably high.

Sir, it is our sincere request to issue the policy circular for reduction in staircase premium charges at earliest to ensure that project progress is not stalled.
