	VAT: The application came up for hearing before the Bench of Hon'ble Shri Justice R.M. Lodha, Shri Justice A. R. Dave and Shri Justice Ranjan Gogoi today. Dr. A.M. Singhvi, Sr. Advocate with Shri Parimal Shroff appeared on behalf of MCHI-CREDAI. The Court has been pleased to pass an interim order extending the date of registration to 15.10.2012 and date of filing of return /payment to 31.10.2012. In case payment of tax/ VAT is made by 31.10.2012, the State Government is restrained from taking coercive steps for recovery of tax/ interest/ penalty. In case the petitioners succeed the amount deposited will be refunded along with such interest as the court may determine.					
	ULC: On 23 rd of August matter did not appear on the board. This matter may appear for final hearing at any day.					
	MOEF: In the above matter so far the union government has not file reply. The matter may come for admission at any time.
