

- **Modification under Section 37(2) to sanctioned Planning Proposals of Bandra Kurla Complex Notified Area.**

**NOTIFICATION**

Whereas, the Government in Urban Development and Public Health Department vide Notification No. BKR 1177/262-UD-5, dated 7<sup>th</sup> March, 1977 under clause (c) of sub-section (1) of Section 40 of the Maharashtra Regional and Town Planning Act, 1966 (Mah. XXXVII of 1966) (hereinafter referred to as "the said Act") has appointed the Mumbai Metropolitan Region Development Authority (hereinafter referred to as its acronym "MMRDA"), established under the Mumbai Metropolitan Region Development Authority Act, 1974 (Mah. IV of 1975), to be the Special Planning Authority for the Notified Area of Bandra-Kurla Complex (hereinafter referred to as its acronym "BKC") ;

And whereas, the State Government in Urban Development Department and Public Health Department vide Notification No. BKR 1177/262-UD-5, dated 9<sup>th</sup> April, 1979, under clause (d) of sub-section (3) of Section 40 of the said Act, has approved the Planning Proposals (hereinafter referred to as "the said Plan") with the Development Control Regulations, submitted by the MMRDA for the development of lands in the BKC;

And whereas, the Land bearing S.No. 378(pt), CTS No. 7643(pt) of village-Kole Kalyan, Tal. Andheri, area admeasuring 35940.68 Sq.mtr., was shown as "Maharashtra Housing Board Transit Camp" in the said Plan;

And whereas, the State Government in Urban Development Department, vide Notification No. TPB-4308/3531/CR-29/2009/UD-11 dated 11<sup>th</sup> March 2010, under Section 37(2) of the said Act, has sanctioned modification to the said Plan in respect of the Land bearing S.No. 378(pt), CTS No. 7643(pt) of village-Kole Kalyan, Tal. Andheri, area admeasuring 35940.68 Sq.mtr., whereby the designation of "Maharashtra Housing Board Transit Camp" on the said land has been deleted and the said land has been included in Residential/Commercial User and an area admeasuring 18,000 sq.mtr. in possession of Maharashtra Housing and Area Development Authority (hereinafter referred to as its acronym " MHADA "), out of the total area of 35940.68 Sq.mtr., is included in Commercial User (hereinafter referred to as "the land under consideration")

And whereas, the MHADA has taken a decision to construct residential tenements for the High Income Group on the land under consideration to generate funds and for cross subsidizing the construction cost of the construction of tenements for the Economically Weaker Sections /Low Income Groups and transit tenements, elsewhere and vide letter dated 17.7.2012





has requested the State Government to issue necessary instructions to the MMRDA in this regard.

And whereas, after considering the request of MHADA, the State Government had issued directions vide order of even No. dated 3<sup>rd</sup> May 2014 under section 37(1) of the said Act. to the MMRDA to submit modification proposal to the said Plan after following the legal procedure stipulated under section 37 of the said Act to the State Government for sanction;

And whereas, the MMRDA vide its Resolution No. 1321 dt. 27/6/2014 has decided to initiate modification to the said Plan and has submitted the modification proposal vide letter dt. 22.12.2014 to the State Government to change the use of the land under consideration, admeasuring 18000 sq.mtr., bearing S.No. 378(pt), CTS No. 7643(pt) of village-Kole Kalyan, Tal. Andheri, from Commercial Use to Residential Use (hereinafter referred to as "the said modification");

And whereas, after consulting the Director of Town Planning, Maharashtra State, the Government is of the opinion that the said modification should be sanctioned.

Now, therefore, in exercise of the powers conferred by sub-section (2) of the Section 37 of the said Act., the Government hereby :-

(a) Sanctions the said modification as below :-

*"The user of the land, admeasuring 18000 sq.mtr., bearing S.No. 378(pt), CTS No. 7643(pt) of village-Kole Kalyan, Tal. Andheri, is changed from Commercial Use to Residential Use as shown on the plan appended hereto"*

(b) Fixes the date on which the said modification is published in the Official Gazette, as the date on which the said modification shall come into force;


(c) Directs the MMRDA that, the schedule of modification appended to the Notification sanctioning the said Plan, after the last entry in schedule of modification, the above entry (a) shall be added.

The part plan showing the said modification shall be kept open for inspection by the general public during the office hours on all working days in the office of the Chief, Town and Country Planning Division, Mumbai Metropolitan Region Development Authority, Bandra-Kurla complex, Bandra (East), Mumbai 400 054.

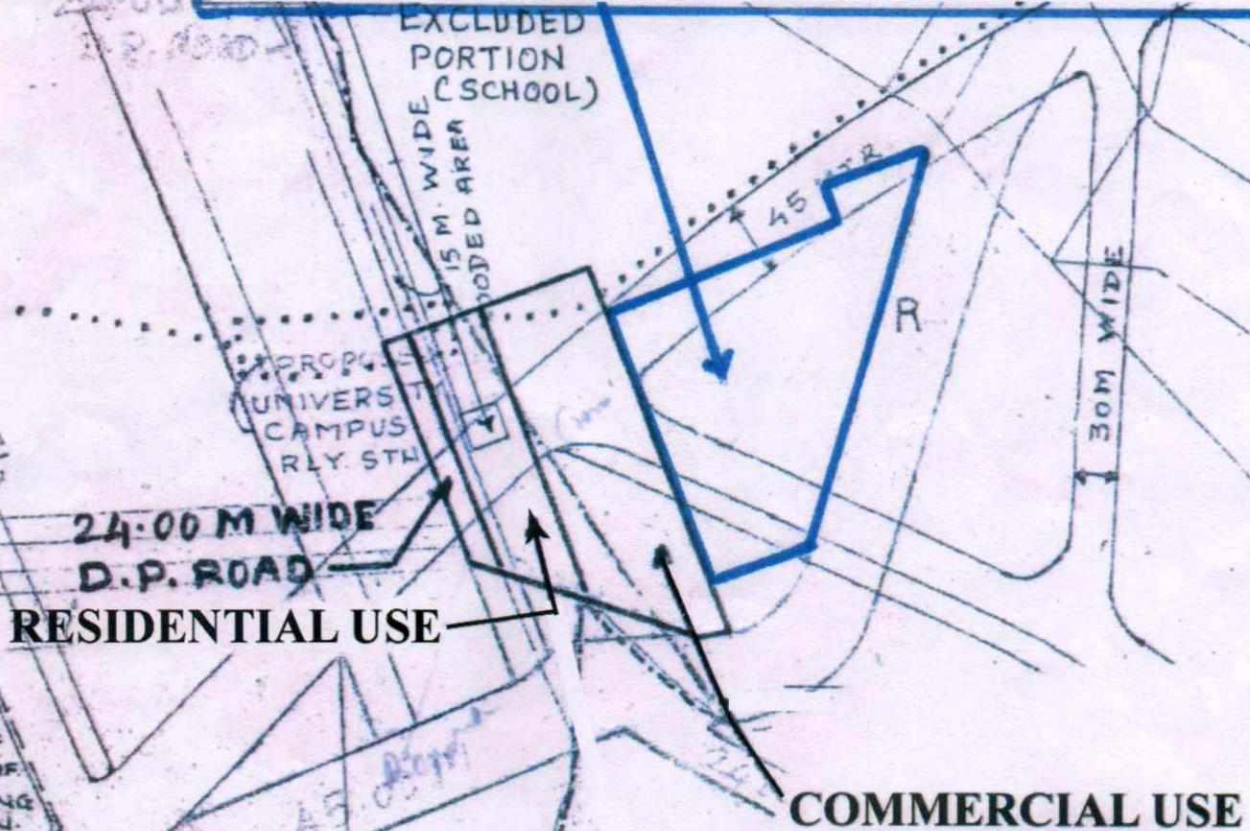
