Project Proponent after obtaining Environment Clearance, which is the process of 10 to 12 months need to apply for Consent to Establish at Maharashtra Pollution Control Board. It takes nearly 2 to 3 months to obtain Consent to Establish. Thereafter Project Proponent can commence the work. Once the project gets completed, the Project Proponent need to obtain Consent to Operate.

After construction is completed, there is no environment concern, except human waste. Hence as per Judgement of Delhi High Court, Consent to Establish and Consent to Operate is not required and should be deleted for construction projects. Alternately, the process of applying for Consent to Establish and Consent to Operate INVITEE MEMBERS retariation be made online. It will save unnecessary waste of time.
