Sub: **MCGM instructed to Control Malaria at your Construction Sites**

Dear Friends,

This is to inform you that a meeting of "**Mosquito Abatement Committee**" took place on 13th December, 2011 with Smt. Manisha Mahiskar Addl. Municipal Commissioner MCGM.

In order to control malaria in the city of Mumbai, Addl. Municipal Commissioner has requested for proactive efforts from MCHI members.

She has specifically requested a **special drive for Baseline Survey of all workers in the month of January (From 15th to 31st January)** to be undertaken by developers & thereto every time any new worker attends the site his blood smear to be done for early detection & treatment of Malaria. This will be the responsibility of the developer who will have to bear the cost.

MCHI has also requested to keep their sites mosquito proof by adopting following measures:

- Instruction issued vide CH.E/812/DP dated 03.08.2010 (**Circular Enclosed**).

- Prevention of Stagnation of Water
- Make all water storage tanks mosquito proof.
- Stop all leakages
- Pot holes / any excavation done for developmental work to be filled in timely
- Chemical Curing
- Site Correction
- Indoor Residual Spraying (IRS) in the dwellings at the construction site to prevent malarial transmission.
- Ensuring hygienic site conditions
- Baseline survey & screening at regular basis for malaria with timely treatment.
- Maintain Health Card for every worker **(Enclosed)**
- Service of qualified medical practitioner
- Distribution of insecticide impregnated nets
- Temporary shelters to be treated with the appropriate insecticides.
- Reporting of Cases.
- Appoint liaison officer to coordinated with MCGM
- Quick response to requisitions made from MCGM.

Any latest circular/guidelines issued by Municipal Corporation from time to time in concern to controlling of malaria in the city will be forwarded to you at the earliest.

C I R C U L A R

Sub: Action to be taken at construction sites during monsoon period to control spread of malaria in Greater Mumbai.

Ref : Circular No. Ch.E./818/DP/Gen. dtd.13.8.2010

You may be aware about circular issued by Director (ES & P) regarding action to be taken at construction sites to avoid breeding of mosquitoes and to control spread of malaria in Greater Mumbai.

In the said circular, it is mentioned that all Developers are mandated to ensure the services of qualified Medical Practitioner at pre announced fixed timings at building construction sites. In continuation of above circular, the following guidelines are issued to control malaria in the City of Mumbai.

1. The said Doctors should examine all construction workers who are having fever or not feeling well on that day.
2. He should take or get his blood smear checked through Pathological Laboratory for testing of malaria..
3. The said Doctor should ensure that complete treatment is given to all malaria +ve patients including Radical Treatment with primaquine, which is given for 14 days for Plasmodium Vivax & One time 45 mg primaquine for Falciparum Cases. The cost toward this testing & treatment should be borne by Developer/ Builder and under no circumstances the construction workers should be asked to pay these charges.
4. The drugs schedule prescribed under Malaria Control Programme is attached herewith for your ready reference. In case of Plasmodium they should ensure that follow up blood smear should be taken on 7th, 14th & 21st day to ensure that malaria is completely cured.
5. They should also report all these cases to the local Medical Officer of Ward for records.

6. They should maintain the Health Card in respect of each worker and make entry in the Health Card about the treatment given, date and other outcomes.
7. In case of new workers employed at construction site they should examine these workers for ensuring that the said workers are not carriers of malaria and should be treated accordingly.
8. They should also ensure hygienic conditions at building construction site.
9. The Medical Officer of the Ward or any person deputed by him should be allowed access to the construction site including all the records maintained in the Health Cards

All Builders/ Developers are hereby requested to ensure that above instructions are followed by Doctors employed by them at construction sites.

CIRCULAR

Sub :- Action to be taken on construction sites during Monsoon period to avoid the breeding of mosquitoes & to control the spreading of Malaria Dieses in Greater Mumbai.


The meeting has been convened by Dir. (E.S. & P.) on 02.08.2010 regarding the above subject matter, various issues regarding remedial measures to be taken to control mosquito breeding over construction sites. The following line of action was decided.


1. The concerned user deptt. / Building Proposal Staff to visit & inspect all the construction sites & ensure that utmost care has been taken by the developer/ builder to keep the site clean and there should not be any stagnation of water, ditches, ponding on site. Further, ensure that necessary arrangement has been made by the developer/ builder on site to make the water storage tank, waterproof and also to ensure that water storage tanks are covered.
2. As far as possible, alternate arrangement of curing will be made on site, so as to avoid water ponding method for curing such as chemical curing, provisions of hession cloth in consultation with respective Architect/ Engineer.
3. The concerned Architect/Site Supervisor/Contractor/Engineer to visit the site at every 7 days during the monsoon period and certificate regarding satisfactory compliance of above points to that effect shall be submitted to B.P. Dept. /concerned user deptt.
4. Ensure the visit of the staff of P.C.O. department on site.


"If it is observed that proper precautions have not been taken by the developer/ builder on site inspite of the instructions necessary action including Stop Work Notice under Section 354-A of M.M.C. Act will be initiated immediately. by B.P. deptt.

All the Building Proposal staff are therefore instructed to visit the sites & to take action with immediate effect as per above directions, and report compliance thereof every fortnight.

In case of Municipal properties, user deptt. shall inspect the respective sites & to insist the compliances as stated in Item No.1 to 4 above. The deptt. shall initiate suitable necessary action as per rules and contract conditions against the concerned contractors etc. and the compliance report of respective deptt. may be submitted to City Engineer/ Ch.E.(D.P.)/concerned D.M.C./Dir.(E.S.& P.)/A.M.C.(W.S.).

Minutes of the Anti - Malaria Meeting

held with Smt. Manisha Mahiskar, Addt. Municipal Commissioner.

Proceedings of the Meeting:

1. Smt. Mahiskar appreciated MCHI for carrying out Anti Malaria campaign advertisements in all the leading as well as local news papers in different languages.
2. She said MCHI efforts have really helped MCGM to control Malaria in the city. Malaria cases registered in 2011 monsoon were comparatively less to monsoon of 2010 though we had started the campaign little late.
3. She said, but this time we are going to start malaria campaign from few months before the monsoon in order to take higher precautionary measures otherwise starting late may registers higher number of malaria cases in the city and may become difficult to control.
4. Shri Nayan Shah Congratulated Addt Commissioner for effectively controlling the malaria menace in the city of Mumbai and ensured MCGM that all the support given by MCHI this year will also be continued for coming years as ongoing process.
5. Smt. Manisha Mahiskar requested MCHI to ensure following preventive measures at the construction sites in the coming monsoon also. They are as under:
 - a. All construction site correction measure to be reiterated & continuously to be monitored by Developer so that no water logging occurs at the site and sites should be free of mosquito breeding.

- b. Special Drive for Baseline Survey of all workers in the month of January (From 15st to 31st) to be undertaken by developers & thereto every time any new worker attends the site his blood smear to be done for early detection & treatment of Malaria. This will be the responsibility of the developer who should bear the cost.
 - c. Instruction issued vide CH.E/812/DP dated 03.08.2010
- 6. Dr. Daksha Shah & Dr. Mangala Gomare brought to the notice of AMC that at the field level on the sites there are certain difficulties faced by Dept. for implementing control measures such as Access to the Sites are denied at certain places. Doctors are not appointed / not attending regularly, Medicines are not provided by the concern developer to the workers and many site supervisors are not aware of requirements of Health Department.
 - 7. Shri Nayan Shah agree that there will be one person from MCHI where all such issues to be forwarded & who will then intervene & coordinated for smooth functioning.
 - 8. Smt. Manisha Mahiskar also raised the issue of MCHI advertisement in the MCGM Anti Malaria Booklet which will last for next 10 years.
 - 9. Shri Nayan Shah ensured the MCHI members will be happy to give advertisement in the MCGM Anti Malaria Booklet.
 - 10. Shri Nayan Shah also said that we will together work out budget for News Paper Anti Malaria Campaign advertisements as done in previous year.
