Dr. Rakesh Kumar is presently the Director, CSIR-NEERI with a vast experience in the field of Environmental Engineering. He has done his doctorate and M.Tech in Environmental Engineering (IITB), he is also a certified Lead Auditor for ISO 14001 (EARA-UK), RAB-USA. His research specialization is in development of appropriate technology for environmental quality improvement encompassing the field of air pollution, particularly vehicle pollution, hazardous waste management, wastewater treatment and disposal. Dr. Kumar has given a notable contribution in developing technologies for reuse and recycle of domestic and industrial wastewater, which brought a paradigm shift in the country. He has been awarded nationally and internationally for his work on Phytorid remediation technology and has many publications in international journals to his credential. He has undertaken several projects and has many patents and copyrights to his name.

Dr. Krishna Lala is currently a Sr. Project Manager in MHRD sponsored e-Yantra Project at the Department of Computer Science and Engineering, IIT Bombay. She holds a Ph.D. in Life Sciences. She is also highly a accomplished trainer and consultant with versatile experience in the field of waste water treatment and solid waste management (SWM). She has been associated with the SWM Cell established by the Government of Maharashtra in 2002 which was instrumental in the capacity building of the ULBs in Maharashtra, and in planning the implementation of the MSWM Rules 2000, in tandem with the State Government. She has worked at some of the leading institutions such as Harvard Medical School, USA, National Research Council of Canada, Ottawa and NEERI in India and has several publications in both, international and national journals.

Dr. Ketna Atul Matkar is an expert trainer on Solid Waste Management, Food Waste Management and a Consultant – Environment Microbiologist with a vast experience in corporate, academics, independent project management and research. She holds a PhD in Microbiology (DAVV) and PG Diploma in Sustainable Environment Management (SIES-IIEM), Auditor-Integrated Management System (MSME) and is also trained in Integrated Solid Waste Management (MMRDA), Municipal Solid Waste Management in Developing Countries (EAWAG-Switzerland), Politics and Economics of International Energy (Sciences PO-Paris) and Energy Future (University of California). She has expertise in Statistical Designing and Optimization (DOE-SSA). Her specific areas of Interest are Solid Waste Management, Food Waste Management, Renewable Energy from solid agro-waste and R & D based projects related to the fermentation, enzymology, EMS-food waste.
