Dear Sir,

CREDAI-MCHI would like to request the Slum Rehabilitation Authority to kindly consider the eligibility application as per the recent GR issued by the Housing Department, in the interest of the slum dwellers to obtain permanent alternate accommodation. Kindly refer to the GR dt. 18th May 2018, as per this GR the latest cut off should now be considered till 1st January 2011.

In case of all on going slum rehabilitation scheme, where Annexure II is already issued, all those slum-dwellers who claimed to be eligible under GR dated 18th May, 2018, shall be making application for determining their eligibility as per cut off year of 2011. Since such slums are already surveyed and Annexure II is already issued, and work of constructions are going on, and huts are already demolished, it will not be possible to resurvey such slum pockets, where work has already commenced and demolition of huts (partially or completely) is already done.

Due to above reason, we request that in case of all ongoing scheme, where survey has already been done and annexure II is already issued and huts are demolished (partly and fully), all these applications should be considered individually on the basis of the applications made by the slum-dwellers with reference to their eligibility as per the new cutoff date, i.e., 1st January 2011. All the applications submitted under the Slum Rehabilitation Scheme, should be examined at the Dy. Collector's level and for that no fresh survey should be asked for; but individual application for eligibility should be considered on the basis of its profits and papers.

Please consider our request as this shall help in expediting further the application process, thereby making the Affordable Homes in Slum Rehabilitation Schemes a Reality.
