We on behalf of our MCHI-CREDAI Members would like to Thank You for taking up & discussing the issues related to Environment clearance approvals in the MMR region & delays therein with Smt. Jayanti Natrajan, Hon'ble Minister for Environment and Forest, GOI, during your visit to Delhi on 7th/8th May, 2012.

It was reported that post your meeting the Hon'ble Minister had immediately issued instructions & kept the Office Memorandum (OM) in abeyance. However our members informed us that in the meeting of the SEAC on 25th May, 2012, their proposals were again rejected on the basis of the road width being inadequate as per the conditions specified in the Office Memorandum (OM). We are unclear on this issue and would be pleased to inform our members on the facts. May we request we be given the required details.

Sir there is also the other issue related to Environmental Clearances, which also urgently requires your attention. It is extremely crucial that the 2nd committee to expedite projects requiring Environment clearance is appointed immediately. Further they need to be given clear Terms of Reference (TOR). These actions will expedite the approval process plaguing the developments in MMR.
