Sub: Some suggestions with regards to Revalidation/ Extension of ULC order

Respected Sir,

With reference to our Meeting held on Wednesday, September 11, 2019 in presence of Shri Ajoy Mehta (I.A.S.), Chief Secretary, please find our suggestion below regarding Revalidation/ Extension of ULC order;

- 1) On payment of compounding fees calculated @1% of Ready Reckoner rate, towards
 - (i) Revalidation/ Extension will be deemed to have been granted till date of payment of premium as per GR No. NAJAK 2018/G.R.51/NAJAKDHA-1 dt. 01.08.2019
 - (ii) Conveyance already executed by owner should be deemed to be regularized;
- 2) Land Component of the FSI for which OCC is obtained and possession is handed over to flat purchasers, premium should be charged at 2.5% of Ready Reckoner Rate.
- 3) Area which is under Development Plan Reservation should be charged at 2.5% of Ready Reckoner Rate.

Time period for completion for

"removal of record of area under ULCH 20 and prevention to the transfer taken in the land records which was given concession for the purpose of housing, plot development, agriculture, cattle farming, garden etc. should be started and the record of "area for the construction of houses in the limit of 80 sq.mtr. FSI" should be taken".

should be completed within 15 days of payment of Surcharge/ premium/ compounding fees in Government Treasury.
