Please refer our earlier correspondences with Revenue Minister and Additional Chief Secretary (Revenue) regarding our pending issues with the Department.

Sir, we already submitted a letter to you with Ref. No. MCHI/PRES/14-15/066 dtd. 4<sup>th</sup> November 2014 about our suggestions related to the MLRC (Amendment) Ordinance, 2014.

We submitted the representation to the Principal Secretary (Revenue) with Ref. No. MCHI/CEO/14-15/120 dtd. 4<sup>th</sup> November 2014 about ad-interim relief of Hon'ble High Court, dtd. 5<sup>th</sup> September 2011 & 17<sup>th</sup> June 2014. We kindly request you to instruct the Revenue Officials to implement and honor the Court Orders in Royalty matter.

Also we submitted a series of Representations to then Revenue Minister, Shri Balasaheb Thorat about difficulties arising at various offices coming under Revenue Secretary and Settlement Commissioner, while obtaining Approvals and Permissions. We already submitted the Representations to Shri Balasaheb Thorat on following issues:

- (b) Calculation or change of 1% Stamp Duty in respect of Agreement for Development or Joint Venture Agreement, or any agreement, in respect of development of immovable property. (Ref. No. MCHI/PRES/14-15/016 dtd. 24th July 2014)
- (c) Maximum Fees of Rs. 100/- on any Conversion of Partnership to a Limited Company under Chapter IX of the Companies Act, 1956. (Ref. No. MCHI/PRES/14-15/017 dtd. 24th July 2014)
