With reference to my last two D.O. letters MCHI/CEO/13-14/003 dtd. May 31, 2013, & MCHI/CEO/13-14/016 dtd. June 24, 2013, would like to draw your kind attention on important issues on the effect of the Repeal of ULC Act, 1976 under the subject of Urban Land Ceiling.

In our last Meeting with Hon'ble Chief Minister on 09th May 2013, we discussed that the issue was financial. Normally, if use of land is changed from commercial to residential or if the time has to be extended for any project then the government charges fee for such changes. Asking for NOCs etc. causes the hurdles and delays in the Development of projects.

If deemed fit, we would like to get appraised of the progress of the case to expedite solving these issues once for all. Hence I request you to please inform of the development in this regard in last two months and allow me to come to your office as per your convenience to discuss the matter.
