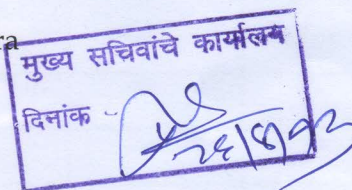


We humbly request you to please ask for the data in the following format from the Collector's concerned for last three years which would be helpful to our members.
