Proposed Modification to Regulation 24.7 of Standardized Development Control and Promotion Regulations for Municipal Councils and Nagar Panchayats in Maharashtra in respect of IT/ITES Policy-2015.

Whereas the Standardized Development Control and Promotion Regulations for Municipal Councils and Nagar Panchayats in Maharashtra (hereinafter referred to as "the said Regulations") have been sanctioned by the Government in the Urban Development Department, under section 37(1AA)(c) of the Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as "the said Act") vide Notification No. TPS-1812/157/CR-71/12/Reconstruction No.34/12/DP/UD-13 dated 21st November 2013, which also came into force from the 21st November 2013;

And whereas, Regulation 24.7 of the said Regulations deals with Information Technology Establishments in respect of additional F.S.I. for Information Technology /Information Technology Enabled Service units (hereinafter referred to as "IT/ITES"), permissible uses in IT/ITES units and payment of premium for additional F.S.I.

And whereas, the State Govt. in the Industry, Energy and Labour Department, vide Notification of ITP-2013/(CR-265)/Ind-2 Dated 25th August 2015, has declared new Maharashtra's IT/ITES Policy-2015.

And whereas, in accordance with the provisions of new Maharashtra's IT/ITES Policy-2015, it is necessary to carry out urgently a suitable modification to the existing Regulation 24.7 of the said Regulation, which is more specifically described in the Schedule-A appended hereto (hereinafter referred to as "the proposed modification").

Now therefore, in exercise of the powers conferred by Clause (a) of subsection (1AA) of Section 37 of the said Act and all other powers enabling in that behalf, the Govt. of Maharashtra hereby, publishes a Notice for inviting suggestions/objections from any person with respect to the proposed modification within a period of one month from the date of publication of this notice in the Maharashtra Government Gazette.

Any objections and suggestions upon the said proposed modifications be forwarded before the expiry of one month from the date of publication of this notice



in Maharashtra Government Gazette to the concerned Divisional Joint Director of Town Planning (As mentioned in Schedule-B appended hereto) who is hereby authorized as an officer on behalf of Government. The objections or suggestions, which may be received by the concerned Joint Director of Town Planning, shall be considered and opportunity of being heard shall be given. Concerned Joint Director of Town Planning is hereby authorized to give hearing and to submit his report to the Government. The Government will take final decision in accordance with the provision of the section (1AA) of Section 37 of the said Act;

This notice shall be kept open for inspection to the general public in the following offices for the above period on all working days:-

- (i) Office of the Director of Town Planning, Central Building, Pune.
- (ii) Office of the Joint Director of Town Planning, Pune, Konkan, Nashik, Nagpur, Aurangabad, Amravati Division.

This notice shall also be made available on the Government website www.maharashtra.gov.in as well as on the website of Directorate of Town Planning www.dtp.maharashtra.gov.in.

SCHEDULE -A

(Accompaniment to Notice No. No. TPB 4315 /CR-146/2015/(1)/UD-11, Dated

The Regulation 24.7 is proposed to be replaced as follows:-

- 1) The Chief Officer may permit additional FSI upto 100% to all registered Public and Private IT/ITES Parks / AVGC Parks, IT SEZs or IT Parks in SEZs and to standalone IT/ITES units in public IT Park (including IT/ITES units located in Residential/Industrial/No Development/Green/Agriculture Zone) which have been approved by the Directorate of Industries, set up under present and previous IT / ITES policies, shall be made available with or without premium as follows:
 - i) Without premium in No Industry Districts and Naxalism affected areas of the State (as defined in the Package Scheme of Incentives -2013 of the State).
 - ii) With a premium of 30% of the prevailing ready reckoner rate in area of Ambernath Municipal Council.
 - iii) With a premium of 10% of the prevailing ready reckoner rate for all other areas in the State.
- 2) Additional FSI above 100 % and upto 200% shall be permissible on plots having an access road of minimum 18 meters width, with or without premium as follows:
 - i) Without premium in No Industry Districts and Naxalism affected areas of the State (as defined in the Package Scheme of Incentives -2013 of the State).
 - With a premium of 30% of the prevailing ready reckoner rate in area of Ambernath Municipal Council.
 - iii) With a premium of 10% of the prevailing ready reckoner rate for all other areas in the State.
- 3) The maximum total permissible F.S.I. shall not exceed limit of 3.00
- 4) Excluding Ambernath Municipal Council area, Maximum 40% Built-up area (excluding parking area) will be permitted for support services in IT Parks and remaining area shall be utilised for IT/ITES.
- 5) In case of Amabernath Municipal Council area, maximum 20% Built-up area (excluding parking area) will be permitted for support services in IT Parks and remaining area shall be utilized for IT/ITES.
- 6) New IT Parks will be required to allocate at least 2% of the built-up area for providing incubation facilities for new units. This area shall be treated as a part of the Park to be used for IT activities, and eligible for additional FSI benefits accordingly.
- 7) A separate fund viz. "Critical Infrastructure Fund for IT/ITES Industries" from the premium paid for availing additional FSI by the Developers of the Private IT Parks



shall be created and this fund shall be utilized only for creation of Critical Infrastructure for IT/ITES Industries.

Provided that in the event, the developer comes forward for provision of such off site infrastructure at his own cost, then the Planning Authority may determine the estimated cost of the works and shall also prescribe the standards for the work. After completion of the works, the Planning Authority shall verify as to whether the same is as per prescribed standards and thereafter, by deducting the cost of works, the balance amount of premium shall be recovered by the Planning Authority .

- 8) While developing site for IT/ITES with additional FSI, support services as may be approved by Director of Industries, shall also be allowed.
- 9) Permission for erecting towers and antenna upto height permitted by the Civil Aviation Department shall be granted by Chief Officer as per the procedure followed for development permission
