## Respected Sir,

Government of Maharashtra has published the Industrial Policy in the year 2013, for facilitating the development of Industry in the State of Maharashtra. Further to that the guidelines for development of Integrated Industrial Area were published on 27/12/2016 by the Industry Department. As per the policy of 27/12/2016 Integrated Industrial Area are permitted in Industrial Zones & also in Agricultural Land, NDZ, Urbanisable zone or areas for which no development plan is sanctioned.

By notification dated 22/01/2018 the Industries Department finalised the conversion premium as 15% of R.R. Rates based on the 26/12/2016 Integrated Township Policy of the Urban Development Department. The Urban Development Department further reduced this conversion premium to 10% in its Integrated Township Policy dated 20/11/2018 & 08/03/2019.

As per the Integrated Township Policy it is clearly mentioned that the conversion premium should be charged considering the agricultural land rate. If agricultural land rate is not mentioned in ASR of the said land in such cases Agriculture land rate in the land same village nearby shall considered. of

We hereby request your good self to issue a clarification that the conversion rates as per the Integrated Township Policy amended from time to time is applicable.
