Sir,

Our society has received a letter on the above subject. We apologize the delay in giving explanation regarding the said letter. As mentioned in your letter, in context with the complaint made by Shri. Janaradhan Mahadeo Gharat & Ors, it is to state that the following explanation is being given on the points raised in the said complaint.

Sir, the five - yearly election of the Managing Committee of Wadala Village Welfare Co-Op. Hsg. Society Ltd for the year 2012-13 to 2016-2017 was held according to the decision given by Hon'ble Supreme Court, Delhi in Special Leave Appeal (Civil) No. (S17265/2012 on 1st October, 2012 i.e., based on the records such as the Membership Register (I Form) Membership List (J Form), Share Certificate Register and Share Certificate maintained by the society. Accordingly, as per the above mentioned records, i.e. Membership Register (I Form, Membership List (J Form), Share Certificate Register and Share Certificate, Shri. Ramesh Gopal Kamble, Smt. Mable Leslie Vera, Shri. Sunil Laxman Jhamdhade & Shri. Neil Joseph Sarav are the eligible members of the society and therefore the members have elected them without affecting their rights. Therefore, the point of Eligibility of the Committee members, raised in the complaint by Shri. Janardhan Mahadev Gharat & Ors., becomes secondary. Further, this is to clarify that till today the elections of Managing Committee members have been held strictly as per the available records of the society i.e. Membership Register (I Form), Membership List (J Form), Share Certificate

Register and Share Certificate. Therefore, the point raised about all the 4 members in the sanctioned Annexure-II of the society, being in-eligible is a secondary point.

Sir, for the 5 years election of the Managing Committee of the members for the year 2012-2013 to 2016-2017, held on 9th December, 2012, Hon'ble Administrator, Wadala Village Welfare Co-Op. Hsg. Society Ltd & Hon'ble Asst. Registrar, Co-Op. Societies, H(East Ward), Mumbai, has considered the objections regarding Membership Register (I Form), Membership List (J Form), Share Certificate Register upto 3rd November, 2012 vide enclosed Circular dt. 19th October, 2012 and prepared a Final List of the members as on 30.09.2012 and displayed on the society's Notice Board and on the Notice Board of Hon'ble Asst. Registrar, Co-Op. societies, H (East Ward) Mumbai on 6.12.2012. It was also mentioned in the said Circular that no changes in the Final List will be made after 6.12.2012. Further the election of Managing Committee members is being held subject to the final decision of Hon'ble Supreme Court. Accordingly the election of Managing Committee members was held.

Sir, in this context, this is to clarify that, amongst the other applicants in the applications submitted by Shri. Janardhan Mahadeo Gharat dt. 7.1.2013, chiefly Shri. Pramod Manohar Dhuri, Shri. Bhanuraj Ghadi, Shri. Arvind Dattaram Kir and Shri Krishna Kashinath Matal had participated in the said elections. It would have been proper that at the very same time, the concerned persons should have taken into consideration the clarification made in the Circular dt. 19.10.2012 of Hon'ble Administrator, Wadala Village Co-Op. Hsg. Society Ltd and Hon'ble Asst. Registrar, Co-Op. Societies, H(East Ward), Mumbai, because the questions/objections raised by Shri. Janardhan Mahadeo Gharat and Ors. would have been clarified at that time itself. Now the objection taken by the concerned is un-understandable.

Sir, the five year election of Wadala Village Co-Op. Hsg. Society Ltd, Managing Committee members for the year 2012-2013 to 2016-2017 is faultless and flawless and in that regard it has been certified by Hon'ble Asst. Registrar, Co-Op. Societies, Mumbai City, SRA Mumbai vide their order dt.10.12.2012. Therefore, Shri. Ramesh Gopal Kamble, Smt. Mable Lesli Vera, Shri. Sunil Laxman Jamdhade and Shri. Neil Joseph Sarav who have been elected on the Managing Committee are eligible as office members. Through this

representation the authority is requested that the rights of Managing Committee in order to bring the dream of poor residents of the members in reality and the rights of looking after the society's functions and to take policy decisions, should be continued unaffected.
