



To exclude the area of "A" Block from the notified area of Bandra- Kurla Complex under the Jurisdiction of MMRDA as a Special Planning Authority

Whereas, the Government in the Urban Development & Public Health Department, vide Notification No.BKR-1177/262 UD-5, dated 7th March 1977, has appointed the Mumbai Metropolitan Region Development Authority (hereinafter referred to as "MMRDA") as a Special Planning Authority under sub-section (1) of Section 40 of the Maharashtra Regional and Town Planning Act,1966(Mah. XXXVII of 1966) (hereinafter referred to as "the said Act") for the area notified in the Schedule of the said Notification.(hereinafter referred to as "the notified area of Bandra-Kurla Complex) ;

And whereas, the Govt. in the Urban Development & Public Health Department , vide Notification No.BKR-1177/262- UD-5, dated 9th April 1979 has sanctioned Planning Proposals for a part of the notified area of Bandra-Kurla Complex, under sub-section (1)of Section 115 as substituted by Section 40(3) of the said Act;

And whereas, the Govt. in Urban Development Department, vide Notification No. CMS/TPB 4314/130/CR-42/2014/UD-11 dated 30th August 2014, has amended the boundary of Bandra-Kurla complex notified area vide Notification No.BKR-1177/262 UD-5, dated 7th March 1977 by deleting area admeasuring 27.365 Ha. between Mithi River and Lal Bahadur Shasti Marg;

And whereas, the land in "A" Block (area 47.37 ha.) is owned by Maharashtra Housing and Area Development Authority(hereinafter referred to as "MHADA"). Most of plots in 'A' Block have been developed by allottee of MHADA. The Municipal Corporation of Greater Mumbai has laid down the services like water supply, drainage, roads etc. in 'A' Block;

And whereas, the Vice President & Chief Executive Officer, MHADA vide letter dated 8th October 2014, has requested to exclude 'A' Block comprising of MHADA Layout form BKC notified Area in order to ensure utilization of full potential of FSI granted to MHADA Layout by the State Government in Urban Development Department;

And whereas, the Metropolitan Commissioner, MMRDA vide letter dated 3rd September 2015 has informed to the State Government that. the MMRDA has no objection to exclude area of 'A' block from the notified area of Bandra-Kurla Complex, from planning point of view, on the request made by MHADA;

And whereas, the State Government is of the opinion that the area of 'A' block should be excluded from the notified area of Bandra-Kurla Complex and be included in the area of jurisdiction of the Municipal Corporation of Greater Mumbai as a Planning Authority;

Now therefore, the Government hereby excludes the area of 'A' block (more particularly specified in the plan appended hereto) from the notified area of Bandra-Kurla Complex and includes it in the area of jurisdiction of the Municipal Corporation of Greater Mumbai as a Planning Authority and to this extent amends the Notification No. BKR-1177/262-UD-5, dated 7th March 1977.

The Planning Proposals approved by the State Government vide Notification No. No.BKR-1177/262- UD-5, dated 9th April 1979, shall be in force for the excluded area subject to floor space indices as per Development Control Regulations, 1991 for Greater Mumbai and also subject to the provisions of CRZ Notification dated 6th January 2011, amended from time to time. The development permission already been granted by MMRDA in which development is not completed shall be dealt with in consultation with MMRDA by Municipal Corporation of Greater Mumbai

A copy of this Notification along with plan shall be made available for inspection for a period of one month at the following offices :--
