The said applications are made to the Appellate Committee as per guidelines provided by notifications under S.O. 84(E) and procedures laid under Dara Circular No. 2/2008.

However we regret to inform that since last six months the Appellate meetings are not being conducted and thus bringing almost to a complete halt various constructions for want of clearance and NOCs from your esteem department.

Sir, most of the projects are Government affiliated projects and the approvals will not only resolve issues of our members but also help the Government in a big way.

Also due to the delay in the clearances, financial loss is not only incurred by our members but also by the various Government Agencies, and in
