As you are aware that as per the Memorandum and Article of Association, the members of the Managing Committee shall, from the date of the registration of the Association, to the first general body meeting of the association, be the persons mentioned in the MOA appointed by the majority of the subscriber to the MOA and the rules and regulations therein. It is a very responsible and respectful position and the Managing Committee Members are expected to try to achieve the main objects which are to be pursued by the association in furtherance of the interests of the housing industry. You will appreciate that this onerous responsibility is cast on our esteemed members who are expected to carry the flagship programs of the Association. I am mentioning few points for your consideration and the commitment which the association will expect from each member of the Managing Committee. It also mentions the eligibility for the committee which is the main Standing Committee of our Association.

- 1) Any member who has not defaulted in terms of outstanding dues or any disciplinary action against him.
- 2) Any member who has done sizable work in MMRDA region, with focus on Mumbai.
- 3) Anyone who has had a minimum attendance of 80% in MCHI meets i.e. 12 monthly meetings and 6 other meetings.
- 4) Each Managing Committee member will be given a task as a task owner which has to be fulfilled with MCHI resources as well as with own resources.
- 5) Each Managing Committee member should be willing to contribute heavily towards legal expenses over and above what is collected from ordinary members.
- 6) Each Managing Committee member who has a sense of service.
- 7) Each Managing Committee member who wishes to serve in the interest of MCHI and in the interest of Industry, above self interest.
- 8) Ideally, the member should have been a member of MCHI for a minimum of 5 years.
- 9) Ideally, he should have attended various initiatives like AGMs, exhibitions, study tours, etc.
- 10) Ideally, he should have worked with MCHI or with MCHI units or on MCHI assignments.
- 11) Any member who follows Code of Conduct.
- 12) As a part of Managing Committee, he would be responsible and answerable to 1500 + MCHI members.
