This is in continuation of our past few mails sent to all members. But no response was received from your side. Therefore, MCHI is constrained to request you once again to kindly look into this as to meet these sky high expenses which will not be possible without your monetary help.

We request the members to send in their Cheques/DD to MCHI within 30 days, for Rs. 1 Lakh towards each company registered with MCHI, as Legal Expenses.

Your Cheques/DD should be made in favor of; **MCHI Legal Fund A/c.**

Herein below is mentioned the Current Legal status of the matters filed by MCHI:

1) ULC SLP in Supreme Court;

The Hon'ble Full Bench of High Court, pronounced the Order in favor of Government on 3rd September, 2014. MCHI has decided to file an SLP in Supreme Court challenging the Order dt. 3rd September, 2014.

2) Janhit Manch C.A. No.10193 of 2010;

This SLP is for final hearing at Supreme Court, wherein the DCR permitting the loading of Slum TDR in the restricted Corridor was challenged.

3) Service Tax SLP (C) No.9313 of 2012;

This SLP is filed, admitted and tagged with SLP No.8390 of 2011 matter; the Constitutional validity of the levy of the service tax on Real Estate Industry was challenged.

4) Heritage W.P. No.1564 of 2013;

The petition is filed at High Court, challenging the notice dt.31st July 2012, for declaring any property or precincts as heritage building under DCR 67.

5) Royalty W.P No.6702 of 2011;

In this matter the State had filed a Civil Application to vacate the Interim Stay granted to the members of MCHI through Order dt.5th September, 2011, which was rejected by the Hon'ble High Court on 17th June, 2014.

6) CRZ W.P. No.1387 of 2013;

This petition is filed at High Court, and is at admission stage, the issue challenged was the Notification dt.6 January 2011 and Para 8 (V) (iii) (b) 2, to be set aside.

7) MOEF (NGT) W.P. No. 1140 of 2014;

This petition is filed at High Court, and is at admission stage and the issue of challenging the OM & Circulars for allowing construction activity upto 20,000 sq.mtrs without obtaining prior consent from EC are contended in the petition.

8) MPCB W.P No.(L).1732 of 2014;

This petition is filed at High Court, and is place for admission; the grounds challenged in this petition are on obtaining the prior consent under water and air act, without insisting on obtaining the prior permission u/s. 25 & 21 of the Water & Air Act respectively. In light of Delhi High Court Order dt.23rd January, 2012.

9) 43 CA: W.P.No1287 of 2014;

This petition is filed at High Court, it came up for hearing and the Hon'ble Court has asked the Sate/Department file an Affidavit in Rejoinder in the Court, the issue challenged was the provisions of sec.43 CA & 56(2)(vii)(b)(ii) of the Income Tax Act.
