Subject: - Request for Extension of GR Dated 25th August 2015 Issued by Industry, Energy & Labour Dept related to IT/ITES policy 2015.

**Respected Sir**,

Firstly, at the outset, we would like to Congratulate you for the commendable, proactiveness and thought put in for every step taken by the Government to contain the spread of this virus. We are confident that together we can fight this Pandemic and we as an association and each of our member is available at all times at the disposal of the Government to fight this Natural Calamity gripping our city and state and Country.

This Pandemic COVID-19 is going to cause an unprecedent impact on business and liquidity. The outbreak of Coronavirus is expected to further weaken the real estate segment especially residential real estate sector that has already been reeling from the adverse impact of the prevailing liquidity crunch, huge unsold inventory and weak affordability and subdued demand conditions.

It's important to note that on account of various reasons, even before the lockdown, the entire real estate sector had already been pushed into an economic and liquidity recession due to structural changes like Demonetisation, RERA and GST, which had resulted in a huge reduction in job creation as well as job loss in the construction industry. Hence, we request to you please grant extension of the concessions for all IT/ITES Users wherein the validity of such IT/ ITES projects is extended for TEN YEARS beyond 30 June 2020 So the users continue to enjoy the continued benefits from 1st July 2020.



This will be a justice to the Users & IT/ITES sector which has shown phenomenal growth in last 2 decades. Due to Lockdown all the IT/ITES companies have been closed and is a critical time where cash flows are completely dry & an early extension to the GR will be a last straw to break the camel back.
