- 1. Affidavit-in-reply has already been filed by the Heritage Conservation Committee. Learned Counsel for Municipal Corporation of Greater Mumbai (MCGM) states that she will file affidavit-in-reply within one week from today. The State Government shall also file affidavit-in-reply within two weeks from today. Rejoinder, if any, will be filed by 16 December 2013. These petitions shall now be listed for hearing on 17 December 2013.
- 2. In the meantime, the counsel for MCGM prays for extension of time limit for submitting the report to the State Government after considering the objections to the proposed heritage listing of precincts near Shivaji Park.
- 3. While extending the time limit up to 31 January 2014, it is directed that the Corporation shall first take up for consideration the cases where the parties have submitted their application for permission to redevelop. The MCGM shall physically accept such

applications for redevelopment and start processing them in accordance with law.
