Sub: Proposal to undertake Ease of Doing Business (EoDB) in Revenue Matters

Respected Sirs,

Let us take this opportunity to congratulate and laud your government and the Central Government for an array of reforms during the last three years that has led to India's ease of doing business ranking jumping 42 places to 100th in the world now. Path breaking efforts have gone into easing doing of business in Building Plan Approval in MCGM, the benefits of which can be felt on the ground. Initiation of on-line approvals and MahaRERA has empowered the common man with technical information like land title and status of government approvals at the click of a button. It is this collective effort that the ranking of India has improved to 181 from 184 last year, and would continue to see further improvement.

Sir, the humungous efforts put in EoDB under your leadership will surely enhance the potential of the state to attract more investment and growth. Now we would like to draw your kind attention to another vital issue. In order to further the cause of EoDB, similar efforts should be extended to the Revenue Department which is a very vital part of state governance. KEY OBJECTIVES OF EoDB IN REVENUE

- Land records and its entire interface with the development of the state should be virtual & online
- For bringing in reliability of land records, online system needs to be implemented and should be the primary goal - this would ensure issues related to reliability of survey number, exact boundary demarcation & area

- The ultimate objective of this exercise being to achieve indefeasible reliability in terms of title and mutation
- GST has achieved "One Nation, One Tax"; this exercise shall realise "One Land, One Record".
- The downloaded land record should be the prime evidence for the boundary, its survey number and the ensuing area, village number, the tenure, its owners along with those deriving rights out of it and all mutations as per the development like sub-division, amalgamation, roads, gardens, amenity open space, built up reservation etc. which are conditions precedence of an approval; as a process, this needs to be made online with minimum human interface. In line with AutoDCR, this system could be called AutoREV.

It may be pointed out here Sir, that commendable work has been done by **Shri Sanjay Dhikle**, a District Superintendent of Land Records Officer, Government of Maharashtra on GIS based Slum Information Management System (SIMS) solution which consists of four components; Topographical Survey of Slum Clusters & Slum Rehabilitation (SR) Schemes, LiDAR Survey of Slum Huts, Mobile Application for gathering slum dwellers information and Web Application with Web-GIS feature for determining the slum dwellers eligibility for free housing under SR Schemes. The same system could be adapted for geo-spatial mapping of all land across MMR and digitisation of land records.

Sir, we are proud to have you as our Honorable Chief Minister. You have minutely studied, understood all the aspects of real estate, the difficulties of the stakeholders, developers and consumers and thereafter initiated their solution, not on file-to-file basis but framing proper, transparent and effective policies and systems.

At CREDAI-MCHI, we are and would always be with you and assure you of our active involvement and co-operation so that there is no uneven playing field, a customer friendly environment with the change in perception, timely commencement and completion of real estate projects, fulfillment of commitments, win - win situation for all stake holders. ANNEXURE I

Key objectives for undertaking EoDB in Revenue Matters :

- To reduce layers / levels of decision making
- To eliminate duplication of work / decision making at all levels – replication of processes
- To create a time bound decision making and approval process
- To standardise and digitise all processes
- To eliminate human interface across all levels and processes, to the extent possible
- To bridge the gap between intended & ground level compliances
- To bring in the desired changes in working climate and attitudinal transformation

In order to serve the afore-mentioned objectives, various key tasks will have to be undertaken in a time bound manner.

Key Tasks proposed to be undertaken under EoDB :

- To study the current processes across all departments and offices like but not limited to Talathi, Tahsildar, Dy. Collector, Additional Collector, Collector, Additional Commissioner, Commissioner, CTSO, TILR, SLR, DDLR and Settlement Commissioner and to create a process map with timeline
- To create a Manual / SOP of the internal working of each department & office
- To analyse and suggest an optimum process map, organogram and SOP with the objective of eliminating duplication and human interface
- To map all kind of records being maintained by the various departments & offices and suggest an optimum way of doing through effective Document Management System and digitisation
- To update, upgrade and digitise all the land records
- To carry out GIS mapping of all land survey numbers along with land use / type of lands etc.
- To digitise all the processes by way of Document Management System
- To study all Revenue Department approval processes, number of officials and tables involved, optimise and digitise the same with no or minimum human interface
- To study & create a Torrens System for Land Titling in MMR
- To reduce the workload, as they are heavily overburdened, of Collectorate & his lower field staff leading to manpower reduction
