We believe that certain provisions of DCR need to be reflected in the MCZMA's plan under preparation for Mumbai and MMR Region.


Provisions like Slum Redevelopment Schemes, Parking Scheme, Rental Scheme etc which are to create better infrastructure and provide affordable housing to city.
