We are confident that together we can fight this Pandemic and we assure you our continued support from the Members of CREDAI MCHI to be always available and the disposal of the Corporation and the Government in fighting against COVID 19, besides, the contribution already made at MCMCR, NSCI, NESCO, Supply of PPE Kits, donation to SMILE etc.

Sir We are proud to announce that in Mumbai & MMR, Bhartiya Jain Sanghatana, Desh Apnayen & CREDAI MCHI with the support of MCGM & Government of Maharashtra, had kick started 5 Mobile Dispensary Seva Vans, inaugurated by Hon'ble Mayor Smt. Kishori Pednekar on 28th April 2020 to service at Worli hotspot area. Subsequently, we started the services of 7 Vans, in Mulund. More than 8000 patients and 300 patients have been referred as high risk to the Health Authorities. While we are expanding the service in MMR in Mira Road, Kalyan, Thane during this week, we will be scaling up with a greater number of Mobile Vans serving more hot spots in Mumbai as per are target of 200 Vans in Mumbai and MMR.

Dispensary Van with a qualified Doctor and an Assistant operates in various locations in Mumbai and MMR to check the patients who have fever, cold, cough, body ache & other stomach related problems. Announcements are done by the local Corporators and patients visit the van in their lanes for a check-up maintaining social distancing.

Bharatiya Jain Sanghatana is successfully running 114 Mobile Dispensary Seva Vans since 1st April 2020 and have successfully treated more than 2,25,000 patients in Maharashtra. Daily every Mobile Dispensary Seva Van screen 150-200 patients and Suspected Corona virus patients after check-up are referred to the local health authority. Shri. Rajesh Tope, Hon'ble Minister for Health, Government of Maharashtra has already acknowledged and thanked BJS for starting the Mobile Dispensary Seva Van in Maharashtra.



Sir, we would like to thank you as you had already issued a Circular no MGC/A/2894 dated 18th March 2020 with regard to project proponents in consultation with Assistant Commissioner of L Ward can spend towards the quarantine center/isolation center which has been beneficial to many project proponents under Corporate Environment Responsibility (CER) Scheme of MCGM.

## From the Desk of Municipal Commissioner

WHEREAS the Government of Maharashtra, in exercise of the power conferred under section 2, 3 & 4 of the Epidemic Diseases Act, 1897 has framed Regulations for prevention and containment of COVID-19 under no. Corona 2020/CR/58/Aarogya -5 dated 13<sup>th</sup> March 2020.

AND WHEREAS under rule 10 of the said Regulation, the Municipal Commissioner is authorized to take any measures as directed by the Public Health Department, Govt. of Maharashtra for containment of COVID-19.

I, Praveen Pardeshi, Municipal Commissioner of Municipal Corporation of Greater Mumbai, in exercise of said powers conferred upon me hereby direct under rule 10 of the said Regulation to implement the CER activities in Mumbai City as under:-

The circular no. CHE/DP/31375 dtd.06.03.2020 is already issued, wherein the activity is listed about "Fulfilling needs of local hospitals to service the needy and patient care".

Under above now facilities to be provided for Quarantine Centre/ Isolation Ward like providing beds for the patients, catering, cleanliness and housekeeping are required to be provided.

As per the circular dtd. 06.03.2020, the project proponent can spend the amount required to be spent under Corporate Environment Responsibility (CER) in consultation with Nodal Officer i.e Assistant Commissioner of the Ward.

The amount is required to be spent on above mentioned activities as per the guidance and requirement specified by the Nodal Officer, Asstt. Comm. of the Ward. The details of such amount spent shall be certified by the Nodal Officer & proper record of the same shall be kept by the Project Proponent & Nodal Officer for this.

All the Stakeholders, Planning Authorities are directed to note above directions and act accordingly.
