Sub.: Update on Court case (PIL) in Bombay High Court against AAI & further Height Restrictions due to ADS-B technology.

Dear Sir,

We are pleased to inform you that the Interim Order of the Bombay High Court dated 1st September 2016 which had led to the Appellate Authority not processing any applications for conduct of aeronautical study which were received by it against height restrictions by AAI has now been modified by the same courts order dated 23rd March 2017 wherein the Court has allowed the Appellate Authority to process such applications and start conducting aeronautical studies and submit its report to the Court. Sir, it is our humble request that in light of the time that has been lost from September 2016 till date which is almost 7 months, if directions can be given to the Appellate Authority to process the applications expeditiously as the waiting list would have increased in this period.

Further Sir, we wish to bring to your attention that there are certain modifications in the parameters pertaining to calculation of permissible heights by applying certain additional procedures/criteria (CNS parameters, ADS-B, etc), which we believe may be restrictive in nature and might lead to drastic reduction in permissible heights. Your urgent attention is required to address these contrasting measures or limiting conditions that may not allow Mumbai to reach its true development potential.

May we suggest that you urgently set up a Committee comprising of technical representatives for examining the possibility of conduct of aeronautical study without taking into consideration such additional procedures/criteria that may have been adopted. Alternatively, the Committee may review these procedures/criteria & adopt them to an extent which permits grant of additional heights without hindering the aircraft operational safety with respect to CNS parameters, ADS-B, etc.

In this regard, we seek your appointment for a joint meeting along with the officials who have been marked on this letter for an in-depth meeting to resolve this issue urgently.
