**Sub: Request to urgently address last mile issues to unlock the real estate potential of MMR.**

Respected Sir,

CREDAI-MCHI extends its Heartiest Congratulations to you and your party to have won the Lok Sabha Elections with a clear mandate, second time in a row. The pro-incumbency sentiments across the country is unprecedented and is a verdict in favour of the hard work done in the last 5 years.
