The complaint has been disposed off as withdrawn because the parties arrived at amicable settlement and filed their consent terms marked Exh."A". Liberty was given to the complainant to get the consent terms executed through the Authority.

- 2. The complainant submits that she has received Rs. 60 lakhs out of principal amount Rs. 65 lakhs.
- 3. On 5th December 2018, two cheques totally amounting to Rs. 5 lakhs were given and on that basis, on the request of the respondents the matter was adjourned for further payment. The complainant reports that both the cheques have bounced.
- 4. One of the employees of the respondents appearing for the respondents submits that legal representative is unable to appear today because of her marriage.
- 5. After taking stock of the situation, I find that Rs. 5 lakhs, the principal amount and the interest accrued till the date have not been paid by the

respondents. Today, also they have not made any payment though the time has been sought for the same by the respondents themselves.

6. In these circumstances, issue recovery warrant under Section 40(1) against the respondents for the unpaid amount. The complainant shall submit the statement showing the balance amount and the interest accrued till the date.
