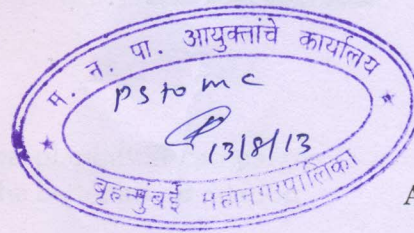




- (6) Prepare well planned tree plantation campaigns to avoid pollution as well as create buffer for the better air circulation.
