1.	To read and confirm the Minutes of the meeting held December 17, 2013 Minutes of the Managing Committee Meeting held on December 17, 2013 were taken as read and confirmed.		
2.	To grant leave of absence to members. As mentioned on Page 1, leave of absence granted to names mentioned (Nos.1 to 14).		
3.	Discussion on the work allotted to the Task Owners concerned. Above point is not discussed		
4.	Legal Matters for discussions.		
	 i. Kohinoor Matter. Discussion regarding review petition filed by MCHI-CREDAI in Supreme Court. It was informed that opinion of Justice B. N. Srikrishna has been received, which categorically opines that layout approval is the approval of plan and once IOD obtained, this Supreme Court Judgment will not apply. President informed that Review Petition has been filed on various 		
	grounds. The same is likely to come up in next week or later. A special request has been made that the Review should be held in open court and not in camera which is usual practice. It was also informed the Govt. of Maharashtra has hurriedly and expeditiously decided to implement all points in the Supreme Court Judgment in words & spirits; that means the part of the DC rules stay.		
	 a. It was also suggested that we should forward this well reasoned opinion to Hon'ble Municipal Commissioner for necessary consideration with a covering letter. b. Writ petition challenging 154(1) directions to be filed. 		
	ii. Writ Petition 2572 of 2013 filed by M/s. Redstone Realtors (Doppler Radar Issue) MCHI-CREDAI has intervened in this Writ Petition for affidavit in reply. The matter was placed on board on January 23, 2014. The information was provided by Shri Pujit Agarwal and CEO. He informed that shadow analysis would help in giving some relief. The matter has been taken to Government of India which will take some time. We have asked for the date of the meeting with New Chief Secretary, Shri J. S. Saharia (I.A.S.).		
	It was suggested by the President that we should seek advice and opinion from some international agency as is available in Civil Aviation like 'ICAO' about study regarding cloud distances & height, its impact on very heavy rainfall, storm, high wind etc. We should request for expeditious date from Chief Secretary.		
	iii. Heritage Petition (Writ Petition No. 1564 of 2013)		
	The Writ Petition along with other petition came up before Hon'ble Chief Justice Mohit Shah and Justice Sanklecha on 3rd February 2014.		
	It was informed that Hon'ble High Court has passed interim order which is received and is available. All precincts declared in last notification to be heritage building, not required to be in the list. That means it is applicable to Grade 1 & Grade 2 Heritage Buildings only. The direction was that in a proposed Heritage Precinct, unless a building is listed as Grade 1 or Grade 2 structure, there is no need for its redevelopment proposal to be sent to MHCC for permission. Redevelopment in Grade 3 area only will require Municipal Commissioner's nod.

	iv	To file a new Writ Petition at Bombay High Court for challenging Sec. 43 (CA)
		It was informed that the Petition is not yet ready, may be in next 15 days.
	v.	VAT 2 nd SLP at Supreme Court.
		The VAT SLP came up for final hearing on 31 st January 2014, before Justice Lodha and Justice Shiva. The Hon'ble Supreme Court clarified that the petitioners will be entitled to appropriate remedy against amendment to rule 58a as per notification dated 29/01/2014.
		It was reported that second SLP order is advantageous to us with right to file as per the old order of Supreme Court or rule 58 (1A) vide notification dated 29.1.2014. VAT is applicable on the material which is incorporated after date of agreement. Sales Tax Commissioner agreed but the staff and Additional Chief Secretary (Finance) did not agree.
		It was also informed that the date of filing Audit Report extended from 15 th February to 31 st March (Trade Circular received) and revised New Writ Petition to be filed in 58 (1A).
	vi.	To discuss about MOEF Writ Petition to be filed against NGT order
		We have received the draft petition finalized by Senior Counsel Shri Milind Sathe. Petition is finalized for filing in the Court. Two references were made, one was order from Delhi High Court and Bombay High Court, in Nashik case which is already filed and decision is expected shortly.
		3 Writ Petitions to be filed –
		i) One which is already settled to be filed.
		ii) Based on Delhi HC order, file another WP
		iii) On the various points raised by Shri Mayur Shah about concept plan, that MOEF should not go ahead with DCR related issues, 105 days deemed approval.
	vii.	Royalty:
		In spite of the stay order from High Court Tahsildar is taking action to recover penalty. We have taken opinion of Advocate, Shri Warunjikar for advice.
		And also steps are taken to file contempt petition against the action taken by the Tahsildar.
		CEO of MCHI-CREDAI has written reminder DO letter to ACS (Revenue) on January 21, 2014 related to the issue of Royalty matter and have personally talk to the ACS and the Deputy Secretary.
		The CEO apprised the committee that the meetings with collector and additional collector, Mumbai Sub-Urban and Additional Chief Secretary, Revenue were held. He had personally discussed the matter with Shri Gutte, Dy. Secretary, Revenue Department who said that the clarification has been issued and copy to be mailed to CEO. It will be verified if it serves the purpose or the Contempt Petition has to be filed.
	viii	Service Tax:
		Service Tax is not payable on the construction prior to 1 st July 2010. Notification by Commissioner is bad in law as it declared that entire construction after July 2010 is applicable for payment. The Circular being challenged as, 1) Service Tax not payable. 2) Where O.C. not issued should also be exempted.
