Dear Nishit,

With reference to your e-mail dated 19<sup>th</sup> October, 2012 at 7.48 p.m. to our exhibition committee members regarding departmental officials visiting the site every now and then.

Please note that MCHI-CREDAI is only handling the permissions and license for the exhibition to be held from 1<sup>st</sup> November, 2012 to 4<sup>th</sup> November, 2012, which we have almost completed. Now the question about the departmental people like police, forest and other officials visiting the site needs to be handled by the contractor who are constructing the structure i.e. either by Deepali or by Gobananas. Please note that any and all documentary evidence regarding the structure and workers has to be submitted to the police by the contractor or by Gobananas and not by MCHI-CREDAI.

First of all we do not know how many workers are working at the site and also we do not know from where they have been recruited for this job. We are not concerned about the workers / labor details or the contractor details, since Gobananas has appointed the contractor. If any details are asked for by the departments, then it is Gobananas that needs to be present at the police station along with the contractor and submit the details to them. This is compulsory to record the statement for the police department because in case of any accidents or mishaps taking place during or after the period of constructing the structures. This procedure is to safeguard the interest of the organizers as well as Gobananas. Likewise, any other officials from any other departments visiting the site during the period of set-up will have to be dealt by Gobananas or the contractor.

It is not possible to depute a responsible person from the liaison agency because; his duty is to only obtain the permissions from various departments and not to handle the exhibition site. We reiterate that the exhibition site has to be handled by Gobananas or the contractor. We believe that Gobananas have a professional team of experts to handle these small issues if and when they crop up.

We will always give our guidance and support wherever and whenever required by you, to make this show successful.

Please note that we are always co-operative and supportive, because it is MCHI-CREDAI show and not Gobananas show.
