With respect to your email dated 22<sup>nd</sup> September 2018 in view of the Hon'ble Supreme Court Orders dated 15.03.2018 in the S.L.P.(C) No. D23708 of 2017, while we as the apex body of developers have been sending regular advice to our members for compliance, taking cue of your note we shall be sending fresh advisory to our members for strict and unconditional compliance.

Sir, we have taken note of the discussion and observation made in the SWM Monitoring Committee meeting held on 26/9/2018 wherein Hon'ble Chairman desired that MCHI/NAREDCO/Stake Holders shall submit the Vision/Action Plan for disposal of C&D waste for 5 years period, after duly considering the quantum of C&D Waste generated through likely construction activities. Drawing out such a vision/action plan cannot be an academic exercise, rather has to be well thought out strategic document taking advice and feedback from various stakeholders in the Real Estate value chain. In order to do justice, a bare minimum of preparation time of 2~3 months is what is being envisaged, with this plan comprising of identification of Landfill sites and all allied aspects such as Landfill Site Capacity, ownership, probable date of expiry etc.

In light of the above, please grant us time until end of January 2019 to present to you a comprehensive C&D Waste Management Plan.
