### JOINT DECLARATION

This Joint Declaration ("this Joint Declaration") is made and executed at Mumbai on this TWENTY EIGHTH day of April, in the Christian year Two Thousand and Ten:

#### BETWEEN

THE GOVERNMENT OF MAHARASHTRA, having its office at Mantralaya, Mumbai 400 021, and represented by its Chief Secretary, Shri J. P. Dange, hereinafter referred to as "the GOM" (which expression shall, unless the context otherwise requires, mean and include the Government of Maharashtra and all its departments) of the ONE PART

#### AND

MAHARASHTRA CHAMBER OF HOUSING INDUSTRY, a Society incorporated under the Societies Registration Act, 1860 and duly registered under the Bombay Public Trust Act, 1950 having its registered office at Maker Bhavan – II, 4<sup>th</sup> Floor, 18, V. Thackersey Marg, New Marine Lines Mumbai 400 020, and represented by its PRESIDENT, SHRI. PRAVIN H. DOSHI, hereinafter referred to as "MCHI" (which expression shall, unless the context otherwise requires, mean and include its successors) of the OTHER PART;

#### PREAMBLE AND BACKGROUND:

- A. MCHI is an Association with more than 500 members incorporated under the Societies Registration Act, 1860 and duly registered under the Bombay Public Trust Act, 1950 and has been established with the main objective to promote housing and real estate industry, which aims to satisfy the most basic necessity of all citizens.
- B. The parties agree and acknowledge that today there is a severe deficit of good affordable housing availability in the Mumbai and MMR. Accordingly, MCHI has taken an initiative and a pledge for maximising the construction of more Affordable Homes in the Mumbai and MMR known as "HOMES FOR ALL" and has approached the GOM for its support and aid in the course of enabling the members of MCHI to create more Affordable Homes in the Mumbai and MMR and the GOM has agreed to extend all necessary co-operation, including legislative revamp, development potential incentives to developers, and authorising the nodal agency to provide for a single window clearance to projects comprising Affordable Homes.

### OVERALL OBJECTIVE

The overall objective of the Parties hereto is that immediate steps be taken in order to encourage construction of more Affordable Homes to the end that the housing deficit in the Mumbai and MMR can be reasonably be brought under control hence immediate initiative required to provide affordable homes to the EWS, LIG and MIG groups.

### COMMITMENTS OF MCHI

- A. MCHI hereby pledges and commits that it shall make all reasonable endeavours to be role of facilitator to its members and encourage the members to take up construction of Affordable Homes within projects being developed by such respective members.
- B. MCHI estimates that within a period of 5 years, construction of 5,00,000 (Five Lakhs) Affordable Homes can be achieved by its members within the Mumbai and MMR.
- C. MCHI shall in consultation with its members, from time to time make Proposals and submit the same to the GOM which shall be ultimately aimed to promote the development and construction of more Affordable Homes. MCHI has already formulated suggested guidelines so that bottlenecks in the GOM approved schemes of affordable homes are removed and speedy developments across MMR is achieved through all the GOM schemes. MCHI with GOM shall finalise all such amendments for speedy and viable implementation projects of affordable homes in next 60 days.

### COMMITMENTS OF GOM

- A. The GOM shall from time to time consider the Proposals made by MCHI in good faith and shall take all quick steps including legislative reform and amendments in policies so that all the bottlenecks in implementing affordable homes projects are removed.
- B. The GOM shall direct the nodal agency for approval of all projects involving the construction of Affordable Homes, to grant a single window clearance to all such projects.
- C. GOM shall finalise all such amendments for speedy and viable implementation projects of affordable homes in next 60 days along with necessary administrative directions for the implementation of the same.

### JOINT COMMITTEE

- A. The GOM hereby appoints it's
  - (1) Chief Secretary – Chairman
  - (2) Principal Secretary, Urban Development
  - (3) Principal Secretary Housing
  - (4) MMRDA Commissioner
  - (5) CEO & Vice Chairman, MHADA
  - (6) Municipal Commissioner, Mumbaias the Authorised Representatives.


**RELATIONSHIP**

- A. This Declaration does not create a relationship between the Parties of either a trust, or partnership or agency and it is clarified that the Parties hereto are executing this Declaration on a principal-to-principal basis.
- B. This Declaration merely records the endeavours that each Party hereto is committed towards and the willingness of each of the Parties to strive to achieve the ultimate objective of providing more Affordable Homes within the Mumbai and MMR and does not create legally binding rights or obligations between the parties hereto.

**RESOLUTION**

The said Joint Committee shall meet regularly at least once a week and shall resolve all the possible bottlenecks and bring in appropriate reforms in practise and in policy in next 60 days and accordingly MCHI shall facilitate and endeavour to deliver 5 lakhs affordable homes in next 5 years.

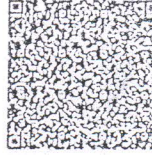

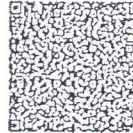

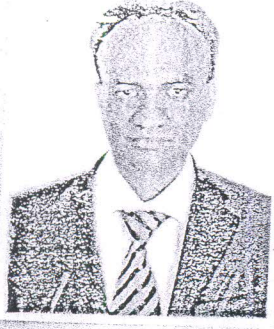
