Sub : Development of projects around prisons

Ref : Government Notification No. JLM-0318/C.R.44/PRS-2 of 9th August 2018

Respected Sir,

We refer to the above subject. In this regard the Government of Maharashtra has amended the prison rules and has constituted a Committee under the Chairmanship of the Municipal Commissioner, MCGM to grant approval to projects situated around the jail prescint. In this regard, we have to inform you that several jail NOC's have been issued by Government of Maharashtra to individual projects and terms and conditions for development have been prescribed in such NOC's. Many of these projects have commenced construction. However, subsequently the MCGM has not granted permissions to these projects despite the Government of Maharashtra having granted NOC/permission prior in time. Several such projects of redevelopment are held up along the jail prescint. Moreover the process of obtaining the Jail NOC also needs to be streamlined so that the rights of innocent people occupying slums and dilapidated buildings situated around the jail are protected in as much as the rights of people in the jail.

In view of the above, we request you to kindly convene a meeting with the Hon'ble Home Minister, Hon'ble Housing Minister and the Municipal Commissioner at the earliest so that the process of granting approval around jail prescint is streamlined and projects that have been granted permission earlier by Government of Maharashtra and where work has commenced can be completed.
