Respected Sir,

SRA by its office order dtd. 02/08/2021 referred at Sr. No. 1 above has adopted MCGM's policy of deferment issued vide its Circular dtd. 17/09/2019 referred at Sr. No. 2 above by charging interest @8.5%. However, the same was in force till 03/09/2021.

We would like to point out over here that the circular of MCGM dated 17/09/2019 was issued with a view to provide stimulus to the housing construction industry in view of the severe stress observed since 2018. However, a large period covered under the said circular of MCGM fell under the Covid-19 Pandemic and the expected benefits could not be realized. In fact, the current scenario continues to be challenging and extension of the said circular is the need of the hour. By taking into consideration the representation of CREDAI-MCHI in this regard, the MCGM vide its Circular referred at Sr. No. 3, has extended the said policy circular for further period of 1 year from 04/09/2021 to 03/09/2022.

Considering the above stated spirit/ purpose of the said policy circulars of MCGM and the fact that the SRA had adopted the original circular of MCGM and to facilitate the smooth & effective implementation of the Slum Rehabilitation Schemes, it would be in the interest of slum rehabilitation to extend the said policy of deferment by charging interest @8.5% for payment of various dues/charges/premiums payable in SRA for a further period of 1 year from 04/09/2021 to 03/09/2021.

In view of the above, we would like to request you to kindly extend the policy of deferment by charging interest @8.5% for payment of various dues/charges/premiums payable in SRA for further period of 1 year from 04/09/2021 to 03/09/2022 on the same lines as done by MCGM.
