Sub: Request for granting 9 months' waiver as initiated by Government of Maharashtra vide notification bearing no. टिपीएस - १८२० / प्र. क्र. ५९ / २०२० / निव – १३ dated 04.06.2020 for the charges to be paid for insecticide treatment done under Pest Control Department of MCGM.

Respected Sir,

Reference is requested to the above notification issued by the Ministry of Housing and Urban Affairs of Government of India dated 28th May 2020, wherein as per the notification an advisory was issued by the ministry for extension of validity and time limit of all approvals, NOCs and subsequent compliances given by State and Central agencies for real estate sector. During the life cycle of a real estate project various clearances with validity and non – validity, are given by different agencies. The Ministry after examining all the facts and the views of the stakeholders involved advised the State/Central Government agencies, States/concerned agencies to:

- i) Consider the situation as 'Force Majeure'
- ii) Extend the validity automatically of various kinds of approvals by ULBs/Urban Development Authorities/other state agencies including commencement/completion certificates, payment schedule of charges including development charges, 'No Objection Certificates' from various agencies by 9 months
- iii) Extend timelines for subsequent compliances by the building proponents as per the precondition of the permission given, automatically, for a period of 9 months.

Subsequently, Government of Maharashtra issued a notification dated 04.06.2020 wherein as per the advisory issued by Central Government on 28.05.2020 due to the Pandemic Covid – 19 and Lock Down, for the 9 months' period extension of timelines was given for all the compliances which includes payables required for permission of buildings by project proponent and also interest waiver was to be given for all the premiums payable during the said period. The said waiver was initially valid up to 26.12.2020 for which the payment had to be made till 10.01.2021.

Accordingly, policy was issued by MCGM in which they stated that for the said period of 9 months i.e. the Covid period considering 'Force Majeure' situation all the payments need to be waived off and no interest can be levied on the payments for the period. Copy of the said notifications and the subsequent circular issued by MCGM are annexed herewith as <u>Annexure - "A", "B"&"C"</u> respectively.

However, certain departments of the corporation have not considered the guidelines mentioned in the above notifications / circulars and have not given extension to the payables or interest waiver for the payables for the said 9 months' period.

Thus, in light of the above facts, we hereby request you to waive off the onetime charges which have to be paid for the insecticide treatment done by the Pest Control Department of MCGM for the said 9-month period or adjust the charges which were already paid to MCGM in the upcoming payments of the said treatment.

We request your urgent and immediate intervention in this matter.
