In continuation to the above referred letter, we would further like to humbly represent as under:

There are several proposals which are in pipeline waiting for approvals and at every level there are huge numbers of files pending for approval. The officers are trying their best to disposed-off the files within the stipulated time limit by working for long hours including working on weekends.

As of now, the total number of pending files with Ch. E. (D.P.) is more than 290 in the console itself and further almost 250+ files are in process which shall reach the office of Ch.E. (D.P.) in coming days.

The majority of the proposals are belonging to Co-operative Housing Societies / tenants who are waiting for Redevelopments to take place for last several years and this is the excellent opportunity the Government has given by reducing premium rates to 50% which is applicable upto 31.12.2021 which will bring viability to the proposals. There are more than 15000 tenements which will be benefited out of this Scheme.

Looking to the backlog and process of pending approvals, we would like to request that payment facility for the cases where concessions are approved by Hon'ble Municipal Commissioner before 31.12.2021, may be extended upto 31.01.2022. Thereby the files which are approved in the last week of December 2021 will get an opportunity to issue IOD / Amended plans by paying various premiums to MCGM / Government.
