4. Presentation by CREDAI-MCHI Women's Wing by -Ms. Mona Ajmera, Hon. Chairperson

Ms. Mona Ajmera, Hon. Chairperson expressed her gratitude to CREDAI-MCHI and President – Shri Boman Irani for giving unflinching support to the Women's Wing from time to time and it was a phenomenal journey.

Ms. Mona Ajmera mentioned that there are 3 objectives of the Women's Wing, which they wanted to take forward, (1) Education for students, (2) Labour Welfare and (3) Events for Members.

- During this year 28 new students were granted with scholarship for the academic year 2022-23. Total 214 students had been granted Education Scholarship till date amounting to Rs. 73,48,961/-.
- Interactive sessions were held for the students to boost their confidence, like session by Shri Kaizad Hateria of Rustomjee Developers.
- The new initiative Ujjwal Bhavishya was taken up by the Women's wing, under which the practical knowledge sessions, site visits, study tours for the students had being conducted.



- Shri Mona Ajmera updated that the health of labour is important and hence 37 health camps were conducted during the year and more than 6300 + labourers were encouraged to give up toxic habits like tobacco, drinking etc. The Women's Wing is thankful to Smt Jayalakshmi Krishnan from Vasantha Memorial Trust and Dr Gunjan Thaker and Team from The Dental Studio for conducting the health camps.
- The Labour Registration campaign was conducted by the CREDAI-MCHI's Women's Wing in association with Maharashtra Building and Other Construction Workers Welfare Board, Mumbai. The access key card of 32 monetary benefits were handed over to the labourers. Through this financial support for children education, health camps, marriage expenses, maternity expenses etc. to be provided to the workers/labourers at construction sites.
- Another initiative of opening of Jan Dhan Bank Account of Labours was taken up by Women's Wing. Account with Bank of Baroda of 74 labours at Dosti North Project and SBI Bank of 12 Labours at Hubtown Prabhadevi project were initiated.
- There were Member's Engagement events being conducted by the Women's Wing like session with Ms. Swaroop Sampat –Rawal, Ms. Ruma Biswas, CPR Session with Shri Ramesh Lad.

Ms. Mona Ajmera, Chairperson further updated that the builder's fraternity is concerned about the safety and security of their labourers at constructions sites which was commendable and the CREDAI-MCHI Women's Wing is looking forward to generous and kind support of the members of CREDAI-MCHI.

5. Presentation by CREDAI-MCHI Units

The Presidents of CREDAI-MCHI Thane Unit, CREDAI-MCHI Kalyan-Dombivli Unit, CREDAI-MCHI Navi Mumbai Unit, CREDAI-MCHI Palghar-Boisar Unit, CREDAI-MCHI Bhiwandi Unit, CREDAI-MCHI Shahapur- Murbad Unit and CREDAI-MCHI Uran – Dronagiri Unit updated the members about the activities carried out by their respective Units during the year.

The Units' representatives expressed their gratitude and welcomed the support extended by CREDAI-MCHI main chapter for formation of new Units as per the geographical locations and the help provided for setting up of the Units, its registration processes, etc. They also thanked the President and Secretary of the Main Chapter, for the guidance and support provided to take up their respective issues faced by the Units, arranging meetings for the Unit's committee members with Ministers, IAS Officers and other Government officers from time to time.

There are training/master classes programs being organised during this property exhibition for the benefit of the developer members. CREDAI-MCHI has collaborated with the knowledge partners, bankers, ancillary industries etc. and panel discussions would be conducted. Shri Nikunj further mentioned that 97% stalls have already been sold out and very few are left, the same shall be sold very soon and looking forward to a successful Expo.

EXPECTATIONS FROM MANAGING COMMITTEE MEMBERS

- 1) Any member who has not defaulted in terms of outstanding dues or any disciplinary action against him.
- 2) Any member who has done sizable work in MMRDA region, with focus on Mumbai.
- 3) Each Managing Committee member will be given a task as a task owner which has to be fulfilled with CREDAI-MCHI resources as well as with own resources.
- 4) Each Managing Committee member should be willing to contribute heavily towards legal expenses over and above what is collected from ordinary members.
- 5) Each Managing Committee member who wishes to serve in the interest of CREDAI-MCHI and in the interest of Industry, above self interest.
- 6) Ideally, he should have attended various initiatives like AGMs, exhibitions, seminars, conclaves, study tours, etc. regularly.
- 7) Ideally, he should have worked with CREDAI-MCHI or with CREDAI-MCHI units or on CREDAI-MCHI assignments.
- 8) Any member who follows Code of Conduct.
- 9) As a part of Managing Committee, he would be responsible and answerable to 1800 CREDAI-MCHI members.

While we do ask that the Managing Committee members to play an active role, we pride ourselves on supporting each other as a team; membership on the Managing Committee will offer you a privileged opportunity to learn and grow with the organization.

RULES & REGULATIONS OF MANAGING COMMITTEE MEMBERS

- 1) There are 12 Managing Committee Meetings in a financial year, one meeting in every month;
- 2) The Strength of the Managing Committee which at any given time shall be 27 members. The tenure of each Elected Committee Member shall be 3 years. 33% (9 members) shall retire at the end of each year, on first come, first out basis. (Clause No. 42);
- 3) A retiring member of the Managing Committee shall be eligible for re-election. (Clause No. 44);
- 4) Newly elected members to Managing Committee shall resume their office immediately after the conclusion of Annual General Meeting. (Clause No. 45 (f) (v));



- 5) Nomination of Invitees: (Clause No. 43 (c))
 The Managing Committee shall have the power to nominate/select 13 persons among the Members of the Chamber who are primarily in the business of Real Estate Development or who, in the opinion of the Committee, would contribute significantly to the Association in particular and industry in general, as Invitee Members on the Managing Committee. The term of each Invitee Member shall be one year while they can participate in the deliberation of the Managing Committee meets, such Invitee Member shall not have voting rights in the proceedings of the Managing Committee.
- 6) Failure to attend meeting (CREDAI Memorandum Clause No. 28)
 If any member of Executive Council or Governing Council fails to attend any consecutive two meetings, without leave of absence on the grounds like health, marriage or death in family or foreign travel or other reasonable ground (except for Confederation duty), then such member shall not have any voting right in subsequent 3 meetings thereof.
- 7) Shun any other Realty Organization (CREDAI Memorandum Clause No. 30)
 No member of CREDAI shall become member of any other Real Estate Development specific organization. This restriction is necessary to avoid misrepresentation / contrary representation about the sector.
