Sub: Amnesty scheme for Penel fees for delayed CTE and CTO from MPCB.

Ref: Circular no BO/MPCB/AS(T)/Circular/B/240227FTS0039

Respected Sir,

This is with reference to above subject, it was understood that the penal fees will be calculated considering 5 years as one term but as per calculation given by MPCB for various proposals it is found that for the proposal of Consent to Establish the calculation is done as per 5 years as one term but for the proposals for Consent to Operate the penalty is calculated considering 1 year as one term.

It is also found that MPCB is charging additional consent fees for each year separately as consent fees over and above one time scrutiny fees and penal charges as above, which is not mentioned in the circular.

The illustrative calculation of comparison for Fees is mentioned below.

Thus, it is seen that the penalty for CTO is almost 5 times that for CTE. Also, though the validity of CTE/CTO is seven years the additional consent fees is charged for every year over and above penalty instead of one time in normal case.

You are requested to issue necessary clarification ASAP to enable to take benefit of the Amnesty scheme.
