2. Project Details:

- a. Construction activity Describe/specify no. of buildings/components in the project, Layout, Material used and scope of construction activity.
- b. List of activities like loading/unloading, storage of material/drilling, excavation etc.
- c. Outline of activities/management to minimize air, noise or any other pollution.
- d. Material management -
 - (i) Details of material used and the storage facilities at the site,
 - (ii) Dust control methods,
 - (iii) Description of current features of construction on the sites including number of trees.

3. Statutory requirements:

- a. Legal compliances: list of permissions obtained including environmental clearances from the respective authorities.
- b. All NOCs from BMC

5. Environmental Management Plan:

- a. Self-Assessment of Environmental pollution at the site including (i) pre-construction, (ii) construction (iii) Construction and Operation.
 - (i) Pre-construction may include outlining the steps for site clearance and preparation, temporary site fencing and waste collection etc.
 - (ii) Construction phase may include measures to control air, water & noise pollution during drilling, grinding & cutting activities, loading-unloading, excavation, storage and transportation and other construction activities and vehicle and machinery management. Emission control measurers for noise, dust control may have to be specified.
 - (iii) Operational Phase plan long term sustainability measures like water conservation, waste recycling & energy efficient designs.

6. Environmental monitoring & reporting:

- a. Schedule of regular monitoring of air, noise and water qualities during constriction and submit these report to BMC on regular basis
- b. Appoint a resource or personnel for continuous monitoring and adhering these environmental measures
