Sub: Request for a joint meeting between The Appellate Committee, Executive Director (ATM-DoAS, CNS & ASM) and stakeholders (CREDAI-MCHI, NAREDCO & PEATA) for an early resolution of various issues affecting Building Heights and Obstacle Limitation Surface Calculations.

Respected sir,

We wish to draw your attention to the various general operational and technical issues faced by the stakeholders pertaining to the grant of Civil aviation NOC (Vide NOCAS) in the city of Mumbai. A Joint working group (Under the chairmanship of Member ANS) was formed in February 2024 and a physical meeting of the Joint Working Group was held on 1st May 2024 for discussing the issues. However, in spite of several reminders from the stakeholders, till date there has been no resolution or communication from the chairman - Joint Working Group.

The pending issues which need to be discussed and resolved are as follows:

1. Restrictions due to CNS Criteria in particular HF Transmitter (Tx) at Juhu and receiver (Rx) at Dahisar.
2. Interpretation of OLS guidelines - Radial distance from the end of the runway to be considered for evaluating the OLS value for AGA limitation.
3. Deletion of shielding principle not applicable in IHS upto 2500 mtrs, and Revisit of application of Contour of Shuttle Radar Topographic Mission (SRTM – USA) data with a vertical tolerance of 16m.
4. Removal of RNP restrictions on Runway 32 as RNP limitations imposed from 2013.
5. Revisit the implemented calculations method with respect to the 5NM buffer applied around the lower MSA vide GSR 770(E) calculations.
6. Withdrawal of SRE criteria for Runway 14 at Mumbai airport.

The stakeholders have been following up with the department since the past few months but haven't been able to get any positive outcome for these pending issues till date.

We strongly urge your intervention on the above representation made by me and request you to set up a joint meeting on priority at MoCA between The Appellate Committee, Executive Director (ATM-DoAS, CNS & ASM) and Stake holders (CREDAI-MCHI, NAREDCO & PEATA) for discussing and representing these pending issues listed above pertaining to the grant of higher heights for civil aviation NOCs without compromising Air safety.
